Barton had a meeting with Cornell Cooperative, they are doing some renovations. The service is quite remarkable.

- For years we have talked about Water and Sewer in our Light Industrial Zone. We have water but unless we find a lot of grant money, it is going to be difficult to get sewer. Barton suggests a new zone, Light Manufacturing allowed in GB Zones. These zones start around Grand St. Think about Lumen Lane, that is GB Zone. They are all Light Manufacturing, which means everything occurs inside the building. Other than deliveries, nothing spills outside of the building.
- Much like the Walkway zone opened new opportunities, Light Manufacturing could provide opportunities allowed in other zones.

He did a webinar with Granicus, which is basically software for STR.

- He attended the DEC Wetland Seminar. The changes being proposed are going to be significant.
- Silver Gardens project has applied for their building permit. They had a preconstruction meeting.

Barton discussed the OPEN DEVELOPMENT application from Ricky Auchmoody.

## Historian – Joan Kelley

Report of Town Historian – February 2024 Queries:

- 1) Vivian Wadlin asked if the Railroad depot on the new sign by Pratt Lumber was the one on the site or the one on the Hudson. I found a number of photos of the building, taken from different directions, and verified that it is was the one on that site.
- 2) Jerry Linwood requested information about the Hudson Regattas. I referred him to Marist College, as they have all Lloyd's information and much more. He is thinking of proposing another Hudson Regatta based on the West shore, possibly with the railcar viewing stands. I suggested he contact CSX, but it's unlikely they could tolerate a disruption in their service.

Donations:

 3 full page copies of the Herald Stateman from Yonkers, dated December 29, 1938. They included an aerial view of the Bolognesi winery which showed many buildings that no longer exist.

Hudson Valley Rail Trail

- 1) Nice article about the signs in the Southern Ulster Times.
- Town Clerk, Wendy Rosinski and I met with the Grant writer and the vendors who are assessing the documents to be digitized. We determined that their initial proposal to produce the digital images on microfiche would not be an improvement. They

suggested another vendor who could take their digital images and make them accessible on the internet. I showed them the 1932 Tax Maps which are in fragile condition.

Historical Items in the Highway Garage

At the Town Board meeting about the proposal to replace the roof of the Highway garage, I asked about provisions to protect the contents of the historical collection stored on the second story. I contacted Highway Superintendent Klotz and he said the whole job would be done in 2 days. I plan to cover the stored paper items, just in case.

Chief Janso and I looked thru the collection to determine if it contained the bones which Warren Sherwood and the Boy scouts dug up at the Slave Cemetery. We didn't find any bones, but there a lot of "stuff" that could be discarded or repurposed. Two large oars, probably used in a Regatta, are taking up a lot of space. I talked to Lennie about displaying them at the Highland Landing building.

WHEREAS, pursuant to the Development Fee Schedule §3.2 the recreation fees collected by the Town of Lloyd from Developers as set forth above are currently allocated as follows: 50% for the benefit of the Town of Lloyd Recreation Capital Improvement Projects, 25% for the benefit of the Hudson Valley Rail Trail Capital Improvement Projects, 25% for the benefit of the Bob Shepard Highland Landing Park Capital Improvement Projects; and

- WHEREAS, the Town Board has determined that it would be in the best interest of the Town and provide financial flexibility for the Town Board's planning for Recreation Projects within the Town if the Town were to amend §3.2 of the Development Fee Schedule to provide that one hundred percent (100%) of the Recreation Fees collected by the Town from Developers will be allocated to the Recreation Reserve and Capital Projects prioritized by the Town Board for Recreation Fields/Parks (Parks include the Hudson Valley Rail Trail and the Bob Shepard Highland Landing Park).
- **NOW, THEREFORE, BE IT RESOLVED**: That the Development Fee Schedule §3.2 is hereby amended to provide that one hundred percent (100%) of the Recreation Fees collected by the Town from Developers will be allocated to the Recreation Reserve and Capital Projects for Recreation Fields/Parks. Effective March 1, 2024.
