4. New Apparatus-

Chief Miller reported that the new ladder truck is delayed; Chief Miller and Chairman DiLorenzo met with Coeyman's Fire District representatives to discuss this delay and they were okay with Th delay. An email was received from Coeymans Fire District that their permissive referendum is complete. E-One's delay (with our new truck) complicates things with Coeymans. Chief Miller has had numerous conversations with the sales rep and regional manager regarding the delivery date.

Commissioner Fraino asked what the reason was for the delay. E-One has significant orders and Had to pause to install a jig; they have 120 ladders on order. E-One is in very high demand. Commissioner Chris Erichsen asked about the contract build date. Chairman Dilorenzo state it is 435 days which brings to May 2020, but there is a 2 to 3-month delay.

Commissioner Chris Erichsen good with holding this one. Commissioner Fraino is good as long as protocols are in place. Chairman DiLorenzo explained that chairs and tables were sanitized prior to the American Red Cross leaving.

Commissioner Chris Erichsen noted that Past Assistance chief Louie Miller passed away.

FURTHER RESOLVED that the Treasurer of the Fire District be authorized to withdraw an amount not to exceed ONE MILLION FOUR HUNDRED NINETY THOUSAND and 00/100 (\$1,490,000.00) DOLLARS from the Capital Reserve Fund heretofore established for Acquisition of Firefighting Equipment, Vehicles and Apparatus and Equipment appurtenant thereto, for the purchase of up to two (2) Fire Engine Apparatus and Equipment appurtenant thereto
