Not only must emergency vehicle drivers provide prompt response of the apparatus, equipment and personnel to provide services to those in need, but as important, must accomplish this task in the safest and most prudent manner possible. As it has in the past, the Board of Fire Commissioners will continue its efforts in maintaining the reasonable balance in prompt emergency response and the safety of the public at large.
