Chairman DiLorenzo called the meeting to order at 7:00 pm, led the salute to the flag and asked for a moment of silence. Chairman DiLorenzo welcomed everyone to the Board of Fire Commissioners regular meeting.

 Welcome Phil DeAngelo from Focus Wealth Management for the 3<sup>rd</sup> quarter update. Almost 3 months and we are up 6% year to date. We had a rough August – October. We were up 20% going into August. Bonds are positive, Stocks are shaky. We will see where we are in January. We are 93-95% funded – this year's lower, contribution covers liabilities. He feels we are in a good spot.

There was a change, TD Ameritrade was purchased by Charles Schwab and the merger was Sept 5, 2023. With the merger, here were some address corrections needed and this was corrected. The portfolio at 12/31/23 – we should be up 8% and that would be 2% over where we should be.

United Air Conditioning – Steve discussed the proposals with John for preventive maintenance two (2) times a year at both Stations. The combined total is \$6435.00. Commissioner Erichsen requested that St 1&2 be quoted separate. Commissioner DiLorenzo will get quotes separated and they will be emailed.

Town of Lloyd Police Department proposal – Commissioner Roloson said this has been an ongoing humidity issue, picking up moisture, & water around unit. 95% recycled 5% fresh air

Garone's Proposal for Snow removal 2023-2026 (3-year contract) – Station 1 & 2 snow removal same prices St #1 is \$650.00 per storm and St #2 is \$425.00 per storm – Upon request of Salt for St #1 will be \$445.00 and St #2 is \$340.00. Commissioner DiLorenzo said the town has been taking care of it. Salt would be upon request.

# **Building & Grounds St #2** – Commissioners Erichsen & Rizzo Garage door is fixed and looks good!

Commissioner Erichsen is working on a grant for handicapped bathrooms, black top, and fuel tanks. Senator Michelle Hinchey's office has funds available for projects like this. We will put a complete list of items together with estimates and submit. We will get an architect involved for renovations for St #2 but looks promising.

A&R Security – Left a message for Donna and they do not have the parts yet. They are waiting for the parts to come in before they can schedule installation. We also submitted an insurance claim for the lightning strike and received payment of \$6995.00 to replace the damaged alarm system less the deductible.

Splitter & 50' Cable - Is here for St #2.

 New Membership: two (2) new members. Austin Beaudette and Josealberto Andrade voted in on 9/5/23 by the Highland Hose Company.

Chairman DiLorenzo welcomed both members. He mentioned there is required training and the Chief will inform you. We have an orientation program. Physicals are done at FirstCare on Rt 299. We are proud that we have very few injuries – medical treatment is through the Highland Fire District. We have approximately 45 members. The more you put in, the more you get out of it. We are proud of the building – always maintained. On the 2<sup>nd</sup> & 4<sup>th</sup> Monday, we have duty night, best night to come to see how the trucks are maintained and where the equipment is located on the trucks. There are meetings, drills/training, and barbecues. We wish you both good luck.

# RESOLUTION OF THE HIGHLAND FIRE DISTRICT, IN THE TOWN OF LLOYD, NEW YORK, ADOPTED OCTOBER 10, 2023 DESIGNATING THE DATE OF ANNUAL ELECTION, DIRECTING PUBLICATION OF NOTICES, AND DETERMINING OTHER MATTERS IN CONNECTION THEREWITH:

The following was moved by Commissioner Kevin Rizzo and Seconded by Commissioner PJ Roloson:

RESOLVED BY THE BOARD OF FIRE COMMISSIONERS OF THE HIGHLAND FIRE DISTRICT, IN THE TOWN OF LLOYD, IN THE COUNTY OF ULSTER, NEW YORK, AS FOLLOWS:

**SECTION 1.** The Annual Election of the Highland Fire District, in the Town of Lloyd, in the County of Ulster, New York (herein called "Fire District") shall be held at Fire District Headquarters in the Hamlet of Highland, Town of Lloyd, Highland, New York in said Fire District, on December 12, 2023, at 5:00 p.m. (Eastern Standard Time) and the polls shall remain open until 9:00 p.m. (Eastern Standard Time) or as much long as may be necessary to enable voters then present to cast their votes. At said annual election, one Fire District Commissioner for a term of five (5) years, commencing on the 1st day of January 2024, will be elected. All duly registered residents of the Highland Fire District shall be eligible to vote. The Secretary is directed to publish notices as required by law.

**SECTION 2.** In preparing such register, the inspectors of election shall comply with the following procedure:

(a) They shall adopt, use, or copy from, the registration list certified and supplied by the Ulster County Board of Elections the names appearing thereon of all persons residing in the Fire District and qualified to vote in such forthcoming Annual Election.

(b) The register for the Fire District shall include as a minimum the space for the name of the voter, his address within the Fire District and a space for his or her signature to be signed by the voter on election day.

**SECTION 3** The Fire District Secretary Shall furnish the inspectors of election, at Fire District expense, with all necessary registration books, papers, equipment, and supplies.

SECTION 4. This resolution was adopted at least thirty (30) days prior to the Election.

**SECTION 5.** The Fire District Secretary is hereby authorized and directed to publish a legal notice informing the resident electors of the meeting of the Board of Elections once at least twentyseven (27) days prior to the Election in the "Southern Ulster Times", newspaper published for Highland, Ulster County, New York, and having a general circulation within the District and hereby designated as the official newspaper for such publication.

**SECTION 6.** The Chairman, Election Inspectors and Ballot Clerks are to be compensated for their services in preparing the registration records and attendance at the annual election.

**SECTION 7.** In Case any of the members appointed herein are unable or refuse to assume or perform the duties required of them, this Board of Fire Commissioners will appoint alternates who are resident electors.

**SECTION 8.** If clerical help is deemed necessary, this Board of Fire Commissioners will consider the appointment of such clerical persons upon request of the Chairman of the Fire District Board of Elections.

SECTION 9. This resolution shall take effect immediately.
