5. Committee Reports-

Buildings and Grounds St.1 -Commissioners Bragg and Barone

<u>Gerard & Associates</u>- Chairman DiLorenzo met with Gerry and reviewed the firehouse for security and card access system . A proposal was delivered regarding cost to prepare specifications for security and a card access system.

Chief Miller stated that there are two goals :

- 1. To improve the alarm system
- 2. Card access

Cost for estimates and equipment spec's is \$1500. Commissioner Erichsen agrees to move for Commissioner Fraino stated we have been kicking around this card/fob access system for several years now. Chief Miller stated that a fob is more durable; perhaps you can have both. Cost for either is comparable.

<u>Ambulance Bay</u>- Chairman DiLorenzo reported that a lock set was replaced in the Ambulance Bay (Mobile Life)

<u>Police Station</u>- Chairman DiLorenzo reported that the kitchen faucet was replaced at the Police Station.

<u>Copier</u>- Chairman DiLorenzo stated that we met with Noel from Bell copier regarding a new copier. Cost to lease is \$140 per month , 63-month lease. Includes maintenance and supplies (toner, labor , parts.) everything but paper. 24,000 prints per year Black ink overage is .014 each, color prints are .09 each. This lease allows a change in equipment any time during the lease.

Cost is based on State and Local Government Pricing. 2000 prints are permitted per month; however, the meter is read every three months and usage is averaged.

<u>COVID 19 Legislation</u>- Penflex is reviewing legal counsel's recommendations. This legislation allows for every Active member to received points pro-rated per month during the designated time period that COVID -19 restrictions were in place in the district. Chief Miller is to send a letter regarding the time period that COVId-19 protocols were in effect.

13. Chief's Report- Chief Miller reported the following:

<u>Cancer-</u> with regard to the high incidence of cancer among firefighters, we are looking at utilizing lockers and gear bags. This would allow firefighters to keep a change of clothes at the firehouse for when they shower at the firehouse. Chairman DiLorenzo stated that we have made the lockers accessible. Need to get copies of keys.

<u>Training</u>- when plans are developed, we will bring it to the Board. Props will be needed; simulators are expensive to purchase.

<u>4 Gas Meters</u>- replacing two; we should have the new meters for HazMat.

<u>31-10</u>- Strobes are obsolete, replacing with LEDs.

Driver Re-Cert- continues

<u>Fire Prevention</u>- planning on holding in April 2021. Programs for 8th grade and 6th grade are planned; upgraded program. Day-care and pre-school program is good as it is.

October 29, 2020- Ulster County Training Center 31-10 and 35 to go.

<u>Storage-</u> looking to move forward with creating storage space in the Community room. If adequate can store fire prevention equipment and use the Fire Prevention office, for other things.

<u>Compresso</u>r- Bauer Compressor dual system is \$150,000 cost. Similar 10 HP compressor is \$50,000 20 HP Compressor is \$72,000. Does the Board want to repair or replace the existing system? Current one is under sized. A Lease purchase option is available. It was noted that we are not buying a car this year. To compose specifications so the Board can move forward with a bid. To repair the compressor cost is \$6800 with no warranty.

<u>Fire Training</u>- chief Miller reported we continue discussions on how to make it work and how LOSAP ties in. Reviewing Law and how we can adapt.

<u>Knox Boxes-</u> Assist. Chief Jeff DiMetro has been reviewing existing ones; new ones to add include Auto Zone. He is making sure keys are up to date and will work. Chief Miller reported we are working with them to get new Knox boxes at new businesses.

<u>Grove St.-</u> working with building department; possible fines can be incurred.

<u>Central Hudson</u>- dredging river on the Poughkeepsie side.

<u>31-60</u>- lights need to be replaced on side. \$9000 quote to convert to LED at a lesser price. Possibly do in house.

<u>Physical Exams</u>- due. Chief Miller is working with the Work Place trying to resolve some issues and investigating Emergency One.

RESOLUTION OF THE HIGHLAND FIRE DISTRICT, IN THE TOWN OF LLOYD, NEW YORK, ADOPTED OCTOBER 13, 2020 DESIGNATING THE DATE OF ANNUAL ELECTION, DIRECTING PUBLICATION OF NOTICES, AND DETERMINING OTHER MATTERS IN CONNECTION THEREWITH:

The following was moved by Commissioner Alan Barone and Seconded by Commissioner Christian Erichsen :

RESOLVED BY THE BOARD OF FIRE COMMISSIONERS OF THE HIGHLAND FIRE DISTRICT, IN THE TOWN OF LLOYD, IN THE COUNTY OF ULSTER, NEW YORK, AS FOLLOWS:

SECTION 1. The Annual Election of the Highland Fire District, in the Town of Lloyd, in the County of Ulster, New York (herein called "Fire District") shall be held at Fire District Headquarters in the Hamlet of Highland, Town of Lloyd, Highland, New York in said Fire District, on <u>December 8 2020</u>, at 6:00 p.m. (Eastern Standard Time) and the polls shall remain open until 9:00 p.m. (Eastern Standard Time) or as much long as may be necessary to enable voters then present to cast their votes. At said annual election, one Fire District Commissioner for a term of five (5) years, commencing on the 1st day of <u>January 2021</u> will be elected. All duly registered residents of the Highland Fire District shall be eligible to vote. The Secretary is directed to publish notices as required by law.

SECTION 2. In preparing such register, the inspectors of election shall comply with the following procedure:

(a) They shall adopt, use or copy from, the registration list certified and supplied by the Ulster County Board of Elections the names appearing thereon of all persons residing in the Fire District and qualified to vote in such forthcoming Annual Election.

(b) The register for the Fire District shall include as a minimum the space for the name of the voter, his address within the Fire District and a space for his or her signature to be signed by the voter on election day.

SECTION 3. The Fire District Secretary Shall furnish the inspectors of election, at Fire District expense, with all necessary registration books, papers, equipment, and supplies.

SECTION 4. This resolution has been adopted at least thirty (30) days prior to the Election.

SECTION 5. The Fire District Secretary is hereby authorized and directed to publish a legal notice informing the resident electors of the meeting of the Board of Elections once at least twenty-seven (27) days prior to the Election in the "New Paltz Times" and the "Southern Ulster Times", newspapers published for

Highland, Ulster County, New York, and having a general circulation within the District and hereby designated as the official newspapers for such publication.

SECTION 6. The Chairman, Election Inspectors and Ballot Clerks are to be compensated for their services in preparing the registration records and attendance at the annual election.

SECTION 7. In Case any of the members appointed herein are unable or refuse to assume or perform the duties required of them, this Board of Fire Commissioners will appoint alternates who are resident electors.

SECTION 8. If clerical help is deemed necessary, this Board of Fire Commissioners will consider the appointment of such clerical persons upon request of the Chairman of the Fire District Board of Elections.

SECTION 10. This resolution shall take effect immediately.
