Water and Sewer – Councilmember Auchmoody Zoning Board of Appeals – Councilmember Guerriero

Guerriero reported that applicant, Raymond Constantino, is looking for a 2-lot subdivision at 136 Bellevue Road. The lot widths are too narrow for the zone. He is asking for relief; one lot is 45 feet short and the second lot is 59 feet short.

E. RESOLUTION made by Auchmoody, seconded by Winslow TO ENACT LOCAL LAW "G" OF 2020

WHEREAS, proposed Local Law "G" of 2020, a local law to amend Chapter 96 "Vehicles and Traffic" to amend Article 3, "Parking, Stopping, Standing and Truck Traffic", by adding a portion of lower Willow Doc Road and Commercial Avenue as no parking zones; and to create Article VA entitled "One-Way Streets" and to designate Ransom Road from the intersection of Haviland Road to the intersection of Mile Hill Road to be one-way in the Northerly direction traveling from Haviland Road to Mile Hill Road was introduced at a meeting of the Town Board held on the 16th day of December, 2020, at 7:00 p.m.; and,

WHEREAS, the Town Board of the Town of Lloyd has determined that this is a Type II action pursuant to the State Environmental Quality Review Act (SEQRA) and is exempt from further proceedings under such act; and

WHEREAS, a public hearing has been held thereon on the 20th day of January, 2021, at 7:00 p.m., at which time all interested persons were given an opportunity to be heard thereon.

NOW, THEREFORE, it is resolved that Local Law "G" of 2020 be enacted as in the form attached hereto as Schedule "A" as fully as if set forth herein, being a local law to amend the Code of the Town of Lloyd, Chapter 96, "Vehicles and Traffic" to amend Chapter 96, Article 3, "Parking, Stopping, Standing and Truck Traffic", and to add a new Article VA entitled "One-Way Streets".

A local law to amend Chapter 96 "Vehicles and Traffic"

Section 1.

Section 96-5 of the Town of Lloyd Code is amended to add the following:

"Name of Side Location
Street

Commercial North Between Meadow Street and Leonta Avenue Court

Willow Dock Road East Side through the cul de sac

From the Intersection with River Road along the Eastside through the entire cul de sac"

Section 2.

Chapter 96 of the Town of Lloyd Code is amended to add a new Article VA entitled "One-Way Streets".

Section 3.

The new Article VA entitled "One-Way Streets" will contain the following provision "Section 96-13 Ransom Road from the intersection with Haviland Road to the intersection with Mile Hill Road shall be a one-way in the Northerly direction traveling from Haviland Road to Mile Hill Road".

Section 4.

This local law shall take effect when filed with the Secretary of State of the State of New York under the Municipal Home Rule Law.
