Report of Town Historian – February 2023

Ulster County is no longer reporting COVID data. Based on data provided by NYS, the number of COVID-related deaths in the county rose from 414 to 420.

1) Jamie Anson was seeking information about her ancestor who worked in an inn at Highland Landing in the early 1900s. She had very little information, so I gave her some general research guidance.

#### Donations:

1) Doug Lester donated some additional 8 x 10 photographs of the dedication of Town Hall. I sent him a thank you letter.

## Rail trail signage:

- 1) Peter Bellizzi has picked up the 6 completed signs. We're looking forward to seeing and promoting them.
  - Abraham Elting Cemetery now known as the New Paltz Landing Slave Cemetery
- 1) I was interviewed by the "Times Union" and an article about the cemetery appeared in the Feb. 27 issue. The same article also appeared in the Poughkeepsie Journal the following day.
- 2) We are working to get all the pieces in place to allow visits by appointment in Spring.

## Research on the local sites

- 1) Research on Franny Reese Park continues.
- 2) Krum Elbow I've traced the owners of the site back to 1800 when Henry van Hoevenbergh, a Rev. War veteran bought the property and built a dock there. Joseph Corning, who bought the property in 1902, had all the roofs of the buildings painted red so the name of the road leading to the site became "Red Top Road".
  - I worked with the Town Clerk to select the appropriate paint color for the new front door of Town Hall. I located several photographs and postcards of Town Hall. The earlier photographs (from the dedication in 1952) were black and white and postcards were not exact color reproductions, but we've settled on a color scheme that represents the best of both.

I participated in a meeting of the 250Rev War Committee and served as an advisor on the UCGS Ulster history round table meeting.

## **Supervisor** – David Plavchak

Grant report from David Jenkins which talks about two programs will be discussed with the Chief. The request for the grants is do 5/1 and 5/11.

There is a program that is called the T-Mobile Hometown Grant Program that had to do with accessibility. The grant request was put in that would make Berean Park ADA compliant; with the grant they would be able to install ADA-compliant bathrooms along with two walking paths one to the pavilion and one to the beach. The request for the grant in the sum of \$50,000 was submitted last week and hopefully, by the summer 2023 we will have an answer.

The CPF program request for the water plant has been resubmitted. This grant of \$3.8 million dollars to refurbish the water plant facility.

Last June we applied for 3 grants to Homeland Security and FEMA. Two of them were for water plant (pump station) generator and one was for the water plant generator. A letter was received last week that they both made it through the sub-application process. We are now moving from Homeland Security to FEMA.

The same letter was received for the undergrounding of the utilities.

#### Water & Sewer – Adam Litman

## **Water Department**

- 1. We are currently back on reservoir water, it is making up 90% of daily production, the remaining 10% comes from the wells.
- 2. Production time is averaging 10 Hrs. per day.
- 3. The crew at the water plant is back to painting in the filter room. (seasonal)

#### Road Crew

- 1. It's utility mark-out season, and the number of mark-outs has increased significantly.
- 2. The crew continues to work with and assist in ongoing projects throughout the town.
- 3. Spring cleanup.
- 4. They are temporary a two-person crew, John Rockwell is out for possibly 6 to 8 weeks.

### **Sewer Department**

- 1. Daily operations continue as usual.
- 2. The crew is finishing up the inside projects, building needed storage racks, reorganizing and inventorying items and has started spring tank cleaning and inspections.

#### 2. OLD BUSINESS

#### A. Mountainside Woods parking question

A suggestion for the Mountainside Woods parking is designating one side of the road for parking. Have parking only on one side so emergency vehicles can get through. No parking overnight. The fire chief and police chief will go to Mountainside Woods and make sure that emergency vehicles are able to maneuver emergency with vehicles on one side of the road.

## **B.** Update on pavilion Bid (including UC ARPA Grant submission)

The price of timber has been a problem. Sean did get a good contact for considerably lesser amount of money that has been mentioned. We have scaled back the pavilion slightly without affecting the appeal to bidders. Going out to bid 4/6/23 and hoping to come in around the \$500,000.00 mark. Alternative is to get the pavilion built and get that into place and doing the restrooms the following year. Sitework will be performed by the highway department. The Pavilion is eligible for an ARPA grant which is a part of the Ulster County Opera program. The due date to apply for the grant is 4/15/23. On 4/27/23 we will set up a bid opening starting at 10 A.M..and see what comes back.

## C. Tillson/Toc Update

Construction has started. Barricades on Toc Drive and on Tilson. The retaining walls on Tilson are being worked on. Central Hudson was in this week moving the gas lines. A temporary light will be set up at the corner of Chapel Hill and 44/55 in the next week or so.

#### I. RESOLUTION APPROVING DEVELOPER'S AGREEMENT

At a workshop meeting of the Town Board of the Town of Lloyd, held at the Town Hall, Thomas Shay Square, 12 Church Street, Highland, New York on the 5th day of April, 2023 at 4:00 p.m.

THE FOLLOWING Resolution was moved by Mazzetti and seconded by \_\_Fraino as follows:

**WHEREAS**, on January 27, 2022 Stewart's was granted site plan review approval by the Town of Lloyd Planning Board ("Planning Board") to redevelop lands as a 3,720 square foot convenience store with self-service gasoline (the "Project") involving property designated SBL ## 96.9-1-32.100, 96.9-1-32.200 and 96.9-1-33.100 and comprising 1.19± acres located at 3733 NYS Route 9W in the Town of Lloyd, Ulster County, New York (the "Site"); and

**WHEREAS**, the Planning Board placed certain conditions on Stewart's site plan approval including but not limited to requiring documentation of Town Board approval of an extension of the municipal water and sewer districts to serve the Site; and

**WHEREAS**, Stewart's has agreed to undertake certain water and sewer improvements at its own costs and to contribute to the cost of certain other water and sewer infrastructure costs necessitated in whole or part by the Project; and

WHEREAS, Stewart's and the Town seek to memorialize their Agreement concerning the development and operation of the Project with respect to: (1) Performance security for public water and sewer infrastructure to be undertaken by Stewart's and dedicated to the Town's water or sewer districts; (2) Stewart's share of the costs for other public sewer infrastructure necessary to serve the Project, and (2) the payment of all applicable Town fees; and

**WHEREAS**, Representatives of Stewart's have consulted with the Town Building Department, the Town Engineers, the Town Attorneys and other representatives if the Town and there has been a Developer's Agreement drafted to address the issues set forth above a copy of which is annexed hereto as Exhibit A; and

**WHEREAS**, the Town Board desires to approve such Agreement and authorize the Supervisor to execute same on behalf of the Town.

## NOW, THEREFORE, IT IS RESOLVED AS FOLLOWS:

1. The Agreement by and between STEWART'S SHOPS, CORP. and the Town of Lloyd, annexed hereto as Exhibit A, be, and the same hereby is, approved.

- 2. The Supervisor, David Plavchak, be, and hereby is, authorized to sign said Agreement.
- 3. Stewart's will post such security as required by this Agreement and pay such fees as required by the Agreement by transmittal of the security to the Town Attorneys and Town Supervisor, in accordance with the Agreement.
- 4. Upon the signing of several duplicates by the Developers' representatives and the Town of Lloyd representatives, one complete duplicate original of the Developer's Agreement is to be filed with the Town Clerk, with other duplicates for the Developers, Planning Board, Supervisor and Town Attorney's office.
