Jami Anson updated the on Mayfest. Ticket sales are going very well. They are looking for volunteers. Vendor sites are sold out. They have 24 wines, liquors, distilleries, beer, hard ciders. Hudson Valley Restaurant Week and a Taste of New York are partners. Metro North is also becoming a partner. People can come up on the train and that will help with traffic.

Peter Bellizzi added that the tickets are for the tasting area and the rest of the market is free.

Moved to next workshop.

Auchmoody said there is a large container there and it is full. It looks like they are cleaning inside the building.

## **Highland Fire District – Supervisor**

Supervisor reported the lease with the Fire District and the Police Department is up.

#### Highland Central School District - Councilmember Mazzetti

Mazzetti reported the District is back to 4 days of in person instruction. The School Budget will soon go out to the public for vote.

Highland Central School District has announced its Valedictorian is Stephanie Klein with an average of 102.9. She plans on attending New York University and has been accepted into the accelerated dental program.

The Salutatorian is Dana Georghiou with an average of 101.8, who will be attending the State University of New York at New Paltz and major in Accounting.

Mazzetti said he and the board came up with a wonderful idea of having the student clubs from the High School run the concession stand at Berean Park and keep the proceeds for their clubs. He has spoken with the school district and they are excited about the partnership

#### **Highland Landing Park – Councilmember Auchmoody**

Auchmoody reported that CSX has pushed off construction until May 3<sup>rd</sup>.

He is working on the back of the parking lot.

They have planted grass in the northwest corner but the fishermen keep walking across it.

He is doing the concrete work to get ready for the rock for the plaque for the late Frank Skartodos.

Then they will build the railings around the porch.

#### **Hudson 7 – Russ Gilmore**

Supervisor reported NYCDPW is releasing an exorbitant amount of water into the Esopus Creek and it is creating a lot of mud and turbidities in the Hudson River.

There are 7 towns, including ourselves, that draw off the river for drinking water. They are writing a letter to NYCDPW to encourage them to stop dumping so much water.

#### **Lights – Councilmember Auchmoody**

Auchmoody reported there are 4 lights out at Bridgeview but he hasn't heard back from Central Hudson.

#### Planning Board – Councilmember Winslow

Winslow reported that tomorrow is the regular meeting and the Villages is still on the agenda, as is the continuation of the Silver Gardens Public Hearing, so they are still taking comments.

Everything else is small, such as lot line revisions.

#### Police - Supervisor

Janso reported their body cams are up and running. They made some major advances on URGENT. They have started Cops and Coffee again. Hopefully next month they will start their Youth Rec League.

Guerriero asked about an accident on 9W/Chapel Hill Road, and Janso said it was serious, but no fatalities.

Mazzetti asked about an accident by Lowes.

Janso responded another serious accident, no fatalities. They have 30 - 40 accidents a month and with the better weather, more people are out. They are enforcing speed and stops

signs to try to curtail accidents. It happens, unfortunately.

Mazzetti asked if they could reach out to NYSDOT to put a no turn on red sign at the Lowe's light. People are going to cross to the Rail Trail when it says walk but people making the right on red are almost hitting them.

Supervisor said they are paving Rt 299, it will go on until mid-May.

#### Hudson Valley Rail Trail - Councilmember Auchmoody

Peter Bellizzi reported that in reference to Hudson 7, he spoke with Mary McKee from the Ulster County Trails Committee and she said there are no fish in the Esopus Creek anymore, they don't go up to spawn because of all the turbidity.

The HVRT voted last night to give a \$5 discount to any member off a Tasting Ticket at MayFest and the Walkway will be offering the same. It is a way to give back to our members.

Jamie Anson said if you go to the website and sign up for membership it will email you a \$5 off coupon to use when you purchase your ticket. And if you buy your ticket in person the day of, you can say you are a member and they will have a membership list to refer to.

An email will be going out to promote this. They all strongly believe they need to give more back to membership.

Anson said there is a new website for the Hudson Valley Rail Trail;

Bellizzi said the new website is quite extensive.

#### Water and Sewer – Councilmember Auchmoody

Auchmoody reported the Committee discussed the Water line for Silver Gardens. They discussed the status of the bore at Highland Landing Park.

#### 2. OLD BUSINESS

**A.** Mazzetti asked the status of the Commercial Ave. Ext Sidewalk. Mazzetti asked about affordable housing.

Chief Janso added they are still doing their wrist band fundraiser for the American Legion.

#### 3. NEW BUSINESS

**A.** Mazzetti asked Chief Janso about people making illegal left turns out of Mayer Drive.

Chief said you can't cross double yellow lines and doesn't know if there are signs there. He will check with Highway.

**B.** Supervisor said he spoke with Mark Ryder at the County Office concerning Affordable Housing and also with Dennis Doyle. We can either set up a committee or reach out to RUPCO. Either the Town can run the program or RUPCO can.

Mazzetti feels RUPCO should take over Affordable Housing.

Winslow said the Planning Board makes the builders accountable. They make sure they enforce, on their end, but it is the enforcement over time with the landlord that needs to be on someone else.

Supervisor said putting aside the units is one thing but that is just the tip of the iceberg. The administrative end is another story.

Mazzetti said landlords are increasing rent by 15-20% - do we have a local law to prevent this.

Supervisor spoke with Johnathan Jacobson's office concerning this.

Guerriero mentioned that the Ulster County Planning Board suggested we call Affordable Housing, Workforce Housing.

Mazzetti said they talked about doing a moratorium on Hotels. He said he is all for business and wants a hotel. Mazzetti asked Murphy if we can change the law to say a hotel must have a restaurant that operates during certain hours, it must have a pool and a conference room. If they build that then it is something we can be proud of as opposed to building a motel, that is something else like a boarding house, which the town does not allow.

Winslow said the problem with that is, in a developer's economic plan to be able to afford that and keep it full.

Mazzetti said 90 rooms at \$75 a night for 365 nights is over \$2 million a year, they can afford it.

Murphy said in reference to the proposal for a hotel by Walgreens, they are looking for height and size variances to make it economically feasible. If you start saying we want restaurants and pools they are going to ask for more size and height.

# 4. PRIVILEGE OF THE FLOOR

Maureen Flaherty from Bridgeview asked what the purpose of the moratorium was and did you meet your goal.

Winslow responded that the purpose was to slow down development and make some changes to our code. Some of the projects were much bigger than they are now and the changes to the code did that, and she feels they did meet their goal.

Supervisor added it also included the changes to the PRRD to make those developments come in front of the Town Board, not just the Planning Board, so the Town Board could have more say in the project as far as size, setbacks and screening.

Winslow added they changed the height requirements.

Mazzetti said he does not believe they met their goal. He said they could have increased the setbacks, green space was successful, some aspects were successful, but he doesn't feel they met all their goals.

Mazzetti and Winslow discussed whether Silver Gardens is 3 stories.

Supervisor recommended they attend the Planning Board Public Hearing of Silver Gardens tomorrow night. They aren't going to get anywhere tonight.

Flaherty asked why the Villages is not staying within the ½ acre zoning. Why are they being allowed to put in as many cottages as they want?

Supervisor said with the PRRD, when and if the project becomes a reality, they will come in front of the Town Board and they will discuss how many cottages can be built.

Steve Lee from Highland Hose said Highland Hose, in conjunction with the PBA, is conducting a 20<sup>th</sup> Anniversary 911 Brick Tribute to commemorate that fateful day 20 years ago, where 412 First Responders made the ultimate sacrifice, to honor them heroism. Flyers are available with all the information.

Mark Reynolds, Reporter, asked about the compliance of the new apartments behind Dollar General. He was told all along they had a plan and when he FOILed for the plan, he was told there is no plan. He asked if the Town was going to make them comply.

Supervisor responded he will talk to the County.

Mazzetti asked Murphy if the projects have to follow our laws.

Supervisor answered that it is the timing of when the law was in effect.

Murphy said if the law was in effect, then it should have been a part of the planning process and part of the approval. If they don't comply, they would be in violation of their approval.

Flaherty said that from a resident's point of view they did not realize Silver Gardens was being built and it was very alarming that there were no Planning Board minutes on the website.

Winslow said Silver Gardens started a couple of years ago and is still going through the process. Nothing has been approved. There is a protocol to follow for the Town's best interest.

Mazzetti and Winslow debated projects.

Mark Reynolds, reporter asked about 9 Commercial Ave.

Supervisor responded they are cleaning out the cork and debris so they can assess what they will do. He has 60 days to complete.

Suzanne Garcia said she feels it is important to let everyone speak.
