THIS AGREEMENT, made the day of 2023 by and between The TOWN OF LLOYD Inc., a municipality of the State of New York having a mailing address and property address at 12 Church Street Highland, NY, Ulster County ("Lloyd"), whose interest in this project is to develop and construct a recreational trail and wayfinding improvements starting on Town of Lloyd's Illinois Mountain and extending through municipal lands to its property at the Hudson Valley Rail Trail and Empire State Trail, collectively called the Mountainside Connector Trail ("Project" see Attachment A), and THE SCENIC HUDSON LAND TRUST, INC., a not for profit 501(c)(3) having an office and place of business at One Civic Center Plaza, Suite 200 Poughkeepsie, NY 12601 ("Scenic Hudson"), whose mission is to protect and restore the Hudson River, its riverfront and its majestic landscape as an irreplaceable national treasure and a vital resource for residents and visitors.

WHEREAS, the parties hereto completed the John Burroughs Black Creek Trail Plan ("Plan") in collaboration with a local Steering Committee; and

WHEREAS, the parties now desire to begin implementing the Plan; and

WHEREAS, the Town Board resolved to support an application prepared by Scenic Hudson from the Office of Parks, Recreation, and Historic Preservation ("OPRHP") through the Environmental Protection Fund ("EPF") and the New York State Consolidated Funding Application ("CFA"); and

WHEREAS, Scenic Hudson secured \$600,000 grant from the Office of Parks, Recreation, and Historic Preservation ("OPRHP") through the Environmental Protection Fund ("EPF") to advance these goals, of which approximately \$102,310 of the grant funds are intended for projects directly within the Town of Lloyd, subject to change due to unforeseen budgetary changes during implementation of the Plan; and

WHEREAS, Lloyd has committed approximately \$57,990 in cash and \$33,160 in-kind labor and administration services as a portion of the overall match in support of the grant award; and

WHEREAS, Scenic Hudson must have the Lloyd's permission to do work on their property; and

WHEREAS, Lloyd desires any work on their properties as shown on a map, hereto attached (see Attachment B) to be conducted according to their wishes and oversight; and

WHEREAS, the parties hereto wish to complete the scope of tasks included in the Plan located at the Berean Park and Illinois Mountain for the Project, as shown on Attachment A; NOW, THEREFORE, the parties hereto in consideration of the terms and conditions herein contained to agree as follows:

1) Lloyd and Scenic Hudson agree to complete the scope of services and budget of the Project in Attachment A, and that the organizations will agree, in writing, to any material changes to the scope of work.

- 2) Lloyd, in order to complete the Project, gives Scenic Hudson (a) full access to the properties as needed for the project, (b) authority to sign the grant contract agreement with OPRHP, (c) authority to execute any and all documents, establishing long-term protections for the property, and (d) authority to execute documents in accordance with items (a), (b), and (c) above.
- 3) Lloyd, in order to complete the Project, gives Scenic Hudson (a) the right to contract for professional design services for construction to be carried out by the Lloyd's Highway Department staff, or upon Lloyd's authorization to change terms of match support (b) the right to construct or install Project improvements, subject to the following terms:
- i. Scenic Hudson and Lloyd shall be responsible jointly for managing the work of any and all contractors secured to complete the Project, and each of Scenic Hudson and Lloyd shall keep the other apprised of all significant developments and shall provide each other with copies of any and all documents and correspondence concerning the work. Such management will be executed in practice through joint decision-making by the Scenic Hudson project manager and the designated contact for Lloyd. In case of disagreement, the final decision will rest with Lloyd.
- ii. The parties shall review and consult with each other to determine how to proceed with the Project, including criteria for selection of the contractors, relevant responsibilities of the parties regarding funding, design and construction of the Project, and the need for public participation in the design or implementation of the Project.
- iii. Scenic Hudson, with input from Lloyd, will issue Requests for Proposals consistent with item (b) and the contracting standards of Lloyd or OPRHP, whichever is stricter, to hire any and all necessary contractors for the Project.
- iv. After the bids have been received, Scenic Hudson shall forward copies in a timely manner to Lloyd and the parties shall review the submissions against minimum requirements and completeness of the application to create a list of bona fide bids. If the lowest bona fide bid exceeds the available funds, Lloyd and Scenic Hudson shall jointly decide on how to proceed. If the lowest bona fide bid does not exceed the funds available for the scope of work, Lloyd and Scenic Hudson shall confer, review the bids, and Lloyd will award to the lowest, qualified contractor to complete the work. Scenic Hudson shall then prepare and review with Lloyd each construction contract, and award the construction contracts in a timely manner.
- v. For each contract, Lloyd will assist Scenic Hudson in managing the contractors including, but not limited to, scheduling work, reviewing work, authorizing change orders and issuing communications with the contractor as provided by the general conditions and terms to each contract.
- vi. Lloyd, in coordination with Scenic Hudson, will be responsible for coordinating and documenting in-kind services and volunteer labor for the Project as per the requirements of the grant.
 - 4) Subject to the limitation of liability provided below, Scenic Hudson and Lloyd shall each indemnify, defend and hold harmless the other against any liabilities, obligations, losses, damages, penalties or claims of any kind, whether contingent or otherwise, and whether or not resulting from third-party claims incurred by the other to the extent arising out of the negligence, bad faith or willful misconduct of the other, the willful breach by the other of its obligations under this Agreement, or violations of law by the other, in each case in the performance of this Agreement by either party or while on, entering or leaving the Property. Lloyd and Scenic Hudson each agree and acknowledge that in entering into this Agreement each is relying on the protection against liability contained in Section 9-103 of the New York State General Obligations Law, as the same may be amended, and that for such purposes Lloyd and Scenic Hudson shall each be deemed "occupants" of the Property.
 - 5) Lloyd and Scenic Hudson shall each maintain in effect at all times during the term of this Agreement, at the sole cost and expense of each, a policy of public liability insurance: (i) having a face amount of not less than \$1,000,000 per occurrence and \$2,000,000 in the aggregate; (ii) naming the other, either Scenic Hudson or Lloyd, as an additional insured party; (iii) providing that such policy cannot be modified or cancelled without at least thirty (30) days prior written notice to the other party; and (iv) issued by an insurance company reasonably acceptable to the other party. A certificate of insurance evidencing such coverage shall be delivered to each party by the other upon execution of this Agreement. Certificates indicating annual renewal shall be delivered to each party by the other no less than

thirty (30) days prior to any policy's expiration. The amounts of insurance coverage specified herein may be amended by mutual agreement of Scenic Hudson and Lloyd.

- 6) Upon completion of the Project, all improvements will become the sole property of Lloyd and Lloyd's responsibility to operate and maintain them.
- 7) Lloyd, Scenic Hudson, and the grant funding source will be mentioned in all press releases, public communications, and social media posts regarding the project. Scenic Hudson reserves the right to review all Lloyd press releases regarding the Project prior to issuance. Lloyd reserves the right to review all Scenic Hudson press releases regarding the Project prior to issuance.
- 8) Lloyd and Scenic Hudson shall comply with all Federal, State and local laws, rules and regulations affecting the conduct of their respective activities.
- 9) Both parties are working to secure additional state and local funding for the Project and agree to comply with any public rules and regulations that might be required to secure funding.
- 10) Nothing contained herein shall be deemed to create any liability or obligation in an individual capacity on the part of the officers, trustees or employees of Scenic Hudson and Lloyd.
- 11) This agreement shall not be assigned by either party without the express written consent of the non-assigning party. Any such purported assignment is void ab initio.
- 12) This agreement shall not take effect and be enforceable until it has been signed by both parties.
- 13) Nothing herein creates a partnership between Scenic Hudson on the one hand and Lloyd on the other. Neither party shall have the power or authority to bind the other except as expressly set forth herein.

J. RESOLUTION

At a meeting of the Town Board, Town of Lloyd, held at the Town Hall, 12 Church Street, Highland, New York, on the 17th day of May, 2023, at 7:00 p.m.

THE FOLLOWING Resolution was moved by Mazzetti and seconded by Fraino as follows:

WHEREAS, the intersection of Chapel Hill Road and State Route 44-55 in the Town of Lloyd is a very busy intersection, particularly during peak commuter times in the mornings and afternoons on weekdays; and,

WHEREAS, the Town Board of the Town of Lloyd has been concerned with the safety of said intersection due to various factors, including but not limited to its configuration on a curve, the limited sight lines and the amount of traffic that passes through it; and,

WHEREAS, the Town of Lloyd has previously requested a turn study for said intersection that was completed in July of 2022, which study indicated a large turn count at said intersection, particularly in the morning and afternoon commuter hours; and,

WHEREAS, due to the current construction on Tillson Avenue and the Tillson Avenue – Toc Drive intersection located within the Town, traffic is being diverted to the intersection of Chapel Hill Road and NY State Route 44-55, and as a result, the NY State Department of Transportation has installed a traffic signal at said intersection on a temporary basis, and

WHEREAS, the Town Board of the Town of Lloyd feels it would be in the best interest of the Town, its residents and all persons using said intersection to have a traffic signal at said intersection on a permanent basis, and

WHEREAS, the Town Board wishes to request that the NY State Department of Transportation conduct a traffic study to determine whether the traffic at said intersection warrants the installation of a traffic signal at that location on a permanent basis.

NOW, THEREFORE, be it resolved that for the reasons set forth above, the Town Board of the Town of Lloyd hereby requests that the NY State Department of Transportation conduct a traffic study at the intersection of Chapel Hill Road and NY State Route 44-55, located within the Town, to determine whether the traffic volume at said intersection warrants the installation of a traffic signal at the intersection on a permanent basis.

THE FOLLOWING Resolution was moved by Fraino and seconded by Mazzetti as follows:

WHEREAS, the Town of Lloyd seeks to hire a consultant firm to work closely with an active group of volunteers to investigate Chodikee Lake and develop a management plan to insure its short and long-term health, and to complete a lake assessment with particular focus on aquatic invasive species, rare amphibian species, and terrestrial invasives. The assessment will be aimed to be the first phase of an invasive species management plan for both Chodikee Lake and the larger Black Creek watershed, and

WHEREAS, the Town has negotiated an agreement with New York-New Jersey Trail Conference (which agreement provides that the Town of Lloyd will hire GEI Consultants, Inc, P.C. to lead all project management and volunteer coordination efforts) to conduct a full lake aquatic plant survey, a Northern Cricket frog survey (a population of which is known to inhabit Chodikee Lake and which are listed as an endangered species in New York State), and to prepare a summary memorandum detailing results of harvesting effort and surveys outlining next steps for lake management, a copy of which is attached hereto and made a part hereof, and

WHEREAS, the Town Board wishes to approve said Agreement; and

NOW, THEREFORE, BE IT RESOLVED that the Town Board of the Town of Lloyd does hereby approve the Town of Lloyd and New York-New Jersey Trail Conference "Agreement", as attached hereto and made a part hereof as EXHIBIT "A", and hereby authorizes the Supervisor to execute said agreement on behalf of the Town of Lloyd.

WHEREAS, the Town has obtained a proposal for lake management services from GEI Consultants, Inc., P.C., to prepare an aquatic and terrestrial invasive species assessment of Chodikee Lake, with particular attention to the Northern Cricket frog, a population of which is known to inhabit Chodikee Lake and which are listed as an endangered species in New York State, as set forth in the Standard Professional Services Agreement with attachments thereto, which is attached hereto and made a part hereof, and

WHEREAS, the aforementioned proposal includes coordination, training and oversight of volunteer water chestnut monitoring and management efforts.

WHEREAS, the Town Board wishes to approve said Agreement; and

NOW, THEREFORE, BE IT RESOLVED that the Town Board of the Town of Lloyd does hereby approve the Town of Lloyd and GEI Consultants, Inc, P.C. "J Standard Professional Services Agreement", as attached hereto and made a part hereof as EXHIBIT "A", and hereby authorizes the Supervisor to execute said agreement on behalf of the Town of Lloyd.
