## Highland Central School District - Councilmember Mazzetti

Mazzetti reported that Superintendent, Thomas M. Bongiovi, has retired. Joel Freer is the new Superintendent of Highland Central Schools. He was the Highland Elementary School Principal. Mazzetti wasn't sure if Freer is an interim Superintendent.

## Highland Landing Park – Councilmember Auchmoody

- Auchmoody reported that he spoke with the contractor, Green Meadows, about the start date for the water and sewer line to the educational building. CPL said it will be a couple of weeks.
- The rock that will be dedicated to Bob Shepard is in place and they have poured concrete around it from the driveway up to the building.
- They are removing the plaques from the bulkhead and are considering placing them on plexiglass on the building. The dedication of the rock, and everything at the park, to Bob Shepard, will take place on October 13<sup>th</sup>, Shepard's 80<sup>th</sup> birthday.

## Lights – Councilmember Auchmoody

- Auchmoody stated that Central Hudson has gotten back to us about the six lights that are out at Bridgeview, they are not going to fix them.
- Auchmoody asked Michael Bragg, from Bragg Electric, to go up to Bridgeview and see if it's just a matter of replacing the bulbs. He'll use a lift truck to check. The light poles are rotting at ground level and are not safe.
- Auchmoody went to Zumtobel and Selux and asked them if they had something in the design packaging that would work. The engineer from Selux, had some pretty cool lights. They wouldn't light as far towards the house as it would across the sidewalk. Of course, we have to go out for bid. First, we have to find the money. It's something that we need to start looking at.

# **Planning Board – Councilmember Winslow**

- Winslow reported that the Planning Board meeting is tomorrow night at 7 PM.
- Selux is open for a public hearing. The applicant is seeking commercial site plan and special use permit approval to construct and maintain a 750 KW solar array in an unused portion of the parcel.
- Stephanie Basciano is open for public hearing too. The applicant is seeking a lot revision between 4 existing lots on Pancake Hollow Rd., located in the R-1 zone and A zone.
- Rover Contracting is also open for public hearing. The applicant is seeking site plan approval to permit construction of a 9,800 square foot warehouse building for storage and maintenance of equipment for a construction company with an attached two-story office and file storage annex totaling 3,000 square feet in size.

The Village in the Hudson Valley is seeking approval for an Assisted Living Facility.

#### **Police – Supervisor**

Pizzuto reported that they had an initial sit-down last week. As you know the Police contract expired over a year and a half ago. We are starting to get ourselves on track to start the negotiations.

#### Hudson Valley Rail Trail – Peter Bellizzi

Bellizzi reported that last Friday they had a Girls 2.5K run on the Rail Trail. 30 girls ran the Rail Trail from the caboose and back. It was a great run. People enjoyed it. They were coming back to the finish line and received major applause.

The Jolly Rovers are continuing their work on the stairs coming up from the old rail bed to the new bed by Black Creek.

The Girl Scouts bog bridge project has been completed on a path off the old rail bed to Black Creek.

#### Water and Sewer – Councilmember Auchmoody

Auchmoody stated that he believes Falcon Ridge is coming back for the Water and Sewer meeting next month.

#### **Zoning Board of Appeals – Councilmember Guerriero**

Guerriero reported that the Stewart Shop – 3733 Route 9W. 96.9-1-33.100 applied for a variance of 1 foot, 8 inches for sign height, and relief of 23% for lot coverage, and this was approved.

## ECC – Councilmember Guerriero

ECC will meet on July 25<sup>th</sup> @ 9 AM up on Chodikee Lake, they are going to remove the water chestnuts. This is done every year. They take them to Kingston where they get burned. They are looking for volunteers and anyone who has kayaks or canoes.

## 2. OLD BUSINESS

- **A.** Supervisor stated that Cablevision contract Public Hearing is still open and it will continue at the next regular meeting.
- B. Mazzetti inquired about the sidewalk on Commercial Ave. Ext.
  - Scott McCarthy, Planning Board Chairman, answered that he recalled from the discussion at the Planning Board meeting that the sidewalk was going to be built on the west side of the apartments where the utility and transformer boxes are, on the left side of the building. The Planning Board felt the slope was too steep and were concerned that it would be a hazard for people walking up and down. Other Board members made suggestions, maybe doing a staging of tiers to snake up, and then the liability issue came up again. They suggested a sidewalk at a different location. The developer said that he would pay for the sidewalk, at that time.
  - Auchmoody reported that they had a meeting on Tuesday with Ali Venkatraman, who owns 9 Commercial Ave. The wall debris is falling into the road. They already closed the road for almost a month till Venkatraman could have it demolished. Unfortunately, Venkatraman thought he was going to knock down the wall and leave it on the ground.
  - Auchmoody told Venkatraman that he can't do this. He needs to get a container and get it cleaned up.
  - Ali (Mr. Venkatraman) agreed to clean up the metal and all of the other stuff that is piled up, in two working days. He also said he would have a fence put up within a week. Now, it's Wednesday, no fence and no clean-up, nothing.
  - Supervisor stated that Giangrasso called Mr. Venkatraman today and he promised that in another week, he would get to it.
  - The building has been placarded by the building department as "unsafe structure".
  - When we were watching the wall come down during the demolition, the next wall in, that's free standing, was wobbling back and forth. Giangrasso has asked an architect to take a look at it, to deem if it's structurally sound or not.
  - There's debris all around the property, there's metal in the front. Under the site plan terms of that building, there's not supposed to be any storage outside. There are pallets in front of the building. There's to be nothing in front of the building, no storage outside in the back, and now there's shredded metal in the front and in the back. There is debris all over.
  - Supervisor said he reached out to one of the national fence companies, he is going to ask the Town Board tonight to move on putting a fence around Ali's property. If some kids get in there, get hurt, get cut, or the wall does come down, we will have a tremendous liability. Whatever we spend on this, it will be levied against his taxes. This is Mr. Venkatraman's building. We can call tomorrow and have a fence put up and then have the building cleaned out, and go from there. Then it will be up to Mr. Venkatraman what he wants to do with the building. In the meantime, the cost comes back to the property owner.
  - **MOTION** made by Auchmoody, seconded by Guerriero, to put a fence up on Mr. Venkatraman's property located at 9 Commercial Ave.

Supervisor stated that he is satisfied with the liaison's report once a month.
