#### **Dog Control** – Andrew McKee **September 2019 Monthly Report**

Received a total of 14 calls this month including 6 calls to service from the New York State Police and Ulster County Sherriff.

Responded to 4 active complaints and/or cases which are now closed or resolved.

Currently have 0 open cases or complaints.

Impounded 0 stray dogs.

No appearance tickets were issued.

There were no dog bites reported.

There were in excess of 8 dogs reported loose in the Town this month. This is unusually high. I would like to urge residents to keep their dogs tied up.

Highway – Superintendent Richard Klotz

Klotz reported that they are finished paving for the year. The highway department has paved five miles of road at a cost of \$500,000.

- He received a bid for the gate at the highway garage, a project that is mandated by NYMIR, and is still waiting for bids on the opener and the electric. The entire project should cost about \$22,000.
- There is also \$22,000 left in the capital project for the transfer station, which he will use to pave over bad parts of the road going up to the transfer station. They will do more in a couple of years as funds allow.
- They have done some work on Mile Hill Road where there was wash out and the road was beginning to sag. They used concrete to correct the problem. Klotz would like to repave that road next year.

**Police** – Chief Daniel Waage

#### Recreation/Buildings & Grounds – Frank Alfonso

Alfonso reported that Tony Williams Park is still getting lots of use by youth football, travel softball (for a small fee), UCCC, the school district, and people having parties. The school is also using the tennis courts at the park, and the rail trail for cross country.

The town field was used by the Highland Business Association to hold the Harvest Fest on Sat., Sept. 28. The field is used for lacrosse practices, and modified soccer uses it

for games.

People are still using the trails and the playground at Berean Park.

Youth basketball is scheduled for Saturdays at the middle school beginning in December. Adult open basketball will be held on Tuesdays and Thursdays at the middle school.

Youth wrestling will be scheduled in January or February.

A senior trip is scheduled for October 20<sup>th</sup>. Alfonso asked Wendy Rosinski, Town Clerk, to speak about the trip.

- Rosinski reported that she and a small committee got together with Alfonso to plan an activity for seniors and decided on a trip to the Clove Creek Dinner Theater in Fishkill. The show, Chapter Two, will take place on Sunday, Oct. 20<sup>th</sup> at 1:00 pm, and includes lunch. The cost to the seniors is \$25, with the balance being funded by the recreation department. Fifty tickets were originally purchased, but the response has been so positive that they are currently up to 68 tickets.
- Regarding buildings and grounds, cleaning and painting is ongoing, and the windows and floors have been cleaned in the town hall.
- Winslow asked if they could talk about upgrades to Berean Park.
- Alfonso said they just completed work on the courts at Tony Williams Field. Those courts had spider cracks and needed to be done or they would have lost the courts.
- At Berean Park, the courts have paving cracks, which are easier to fix. That court was resurfaced in 2011. The question now is how much do they want to invest. The third court, which is basketball, has one end that needs to be milled out. It has roots growing underneath and it cannot be refurbished with what is there. Also, the trees have grown so tall that no sunlight gets to the one section of the court, it grows moss and becomes very slippery. Highway said they can mill it out and perhaps put in lawn and more picnic tables.
- For the tennis and pickleball courts it will cost approximately \$33,000.00 to fix the cracks, resurface and line. The basketball court will cost another \$4,500 to \$5,000 and the fence work approximately \$25,000. When they replaced the fence in 2010, they used a less expensive fence and it needs to be done correctly. These are estimates and the work

would not happen until 2020.

Supervisor asked what other activities go on at the park.

- Alfonso said there is basketball, but he would make it a half court and remove the part that does not get sun. The tennis court lines are official but to make it an official court, it would need 20 feet beyond those lines and there is not enough room for that. It is a good practice court.
- Winslow said they have the money and some grants coming to do this.

Alfonso said they have \$199,000.00 in capital improvement money for recreation.

- Supervisor said the Board and Recreation Director should come up with a vision for Berean Park and a five-year plan, and not just throw \$100,000.00 at it. He also suggested getting input from a couple of community members.
- Alfonso said \$165,000 was spent on Berean in 2012. This included repaving, striping and fencing in the parking lot; refurbishing the wall; doing work on the beach area; painting the buildings; and doing some work on the tennis and pickleball courts. Since then, with capital improvement money, the bathrooms were updated with new sinks and toilets, and a new raft was installed. They also put in a new sewer system. The mulch in the playground area was replaced a couple of years ago, and the swings are due this year.
- Alfonso said he feels the capital improvement money was well spent addressing the major needs of the parks. And if the board decides that additional work needs to be done on the courts at Berean he will follow through in 2020.
- Winslow indicated that fixing the tennis courts, and the fence surrounding them at Berean so the residents can play pickleball is a reasonable request.
- Alfonso will look into what has to happen with the third court, and then maybe they can fix the fence this calendar year. But the court fix won't happen until June of 2020.
- Liz Weisz, resident, said she doesn't think it's a good idea to get rid of the full basketball court at Berean because when they play pickleball in the evening there are always kids playing basketball. She feels all the courts need to be resurfaced, not patched, so they can be used.
- Alfonso said the first two courts are repairable and can be resurfaced for \$35,000, the third court is not salvageable the way it currently sits. There are tree roots growing under it, and the trees block the sun on one end so moss grows on the court. It would be a waste of money to resurface.
- Alfonso clarified for Mazzetti and Winslow that there would be either two courts for tennis/pickleball, and one-half court for basketball, or one court for tennis/pickleball, one multi-use court, and one-half court for basketball.
- Weisz wanted to know what was spent on the Tony Williams courts. Alfonso checked, and said they spent \$23,975 on the three tennis courts, and \$9,900 on the basketball court.

Town Clerk – Wendy Rosinski

- Tentative 2020 Town of Lloyd budget has been prepared; I have emailed copies to each Board member and have additional hard copies in our office.
- Deer Management permits were issued until October 1<sup>st</sup>. If there is an excess in any deer management unit the NYSDEC will notify us and we will be allowed to issue deer management permits for those DMU's.
- 605 Transfer Station permits have been issued to date.
- CSC Holdings first half payment received \$88,450.00 (Cablevision)
- The Deputy Town Clerks attended the Ulster County Town Clerks' and Tax Collectors' Meeting on September 19<sup>th</sup> in the Town of Esopus. The topic was waving the fee for marriage licenses for Active Duty Military Personnel. The state is waving their fee of \$22.50 and the Clerk's office has decided to wave our fee of \$7.50.



Town of Lloyd Planning Board:

Thank you for allowing me to speak today on behalf of residents in the Highland Hills development. We have been attending these meetings since late March! early April with our neighbors to learn more about the projects that were happening on either side of the entrances to our community. At that point in time, there were only 2. Now, just 6 months later, there are a total of 6 big projects that will directly affect our quality of life. Auto Zone Stewart's Views Villages Highland Estates Golden View II

#### October 2, 2019

Residents of Macks Lane have approached the Highland Hills community for help with a petition they created to ask the town board to put a moratorium on these projects until a plan for the massive infrastructure that will be needed is figured out as well as safety of the residents and the environment surrounding these areas. With the amount of traffic and people that will be added to this area safety is also a huge concern. The chief of police has said in meetings with residents from Highland Hills as well as in town board meetings that he only has two officers out to patrol and they rely immensely on the state police.

With the almost 50 residents on Macks Lane, the 169 in Highland Hills and the fact that these petitioners are approaching those that have signed past petitions against projects in the Brookside development, the total is close to 300 voters who are nervous about how fast and close together these projects are arising.

Even as of last week when the Golden View project was announced at the planning board meeting traffic, infrastructure and the environment didn't seem to be a concern, just that some of the board members liked the idea.

We as a community understand that the planning board's job is to review the plans and make sure they are met to code, not to judge what is being built. But we also know that something can be done when it affects quality of life. To the board this may just be 6 separate projects, but to us, the residents that currently reside around this area it represents a big mess. The majority of these projects don't even directly benefit the community living around them. With the Walkway over the Hudson, the town could be benefiting from inviting tourists into our town instead of focusing on storage, Dollar Generals and Auto Zones. We ask you to please consider what these projects will do to our community and if needed create a policy to slow down these project developments so it can be insured that the safety, quality of life and the environment for those currently living in that area are protected. I would like to submit this letter as public record to go into the minutes of tonight's meeting.

RE: Berean Park Tennis, Pickleball, and Basketball Courts

Dear Town Board Members:

On September 4, 2019, a group of Highland residents attended a Town Board Workshop to request that improvements be made to the tennis, pickleball, and basketball courts at Berean Park. The courts are cracked, worn, faded, and need to be resurfaced. In addition, the fencing is no longer effective.

As you well know, Berean Park is located in a large residential area of the town, and can be easily and safely accessed by children, other residents, and visitors alike. In addition, it is the site for the Town of Lloyd Summer Youth Recreation Program, for which local pickleball players acquired a donation to pay for the purchase of pickle ball racquets and balls to add to the program's offerings.

In 2013, the Town Board adopted the Town of Lloyd Comprehensive Plan, which is still in effect. Chapter One, page 16 of the plan highlights the need for improvements to the Berean courts, and implementation of the improvements to be completed within two years.

It is now many years since the Comprehensive Plan was created. Yet, very little has been done to address the poor conditions of the Berean courts—in spite of numerous requests to Town Board Members and the Recreation Department.

The courts at Tony Williams Field were resurfaced just this past month, even though they were in far better condition to begin with than the Berean courts. Pickle ball is not permitted on the Tony Williams courts. So, pickleball players have no recourse but to play at Berean Park. In addition, the use of the Tony Williams courts is limited at times even for tennis players, because the Highland High School Tennis Team has priority. Also, the youth living in other sections of the town can not easily access the Tony William tennis and basketball courts without imposing on their parents for transportation. (Continue on page 2)

Our inquiries indicate there is currently \$190,000 in the town recreation budget. ## CONCERNED CITIZENS LETTER TO THE TOWN BOARD - ATTACHMENT B

### The Benefits of Offering Pickleball In Our Community:

According to the United States Pickleball Association, pickle ball is the fastest growing sport in America. Many neighboring towns and educational institutions, including the City of Kingston, Ulster County Community College, and SUNY New Paltz, have recently increased their number of pickle ball courts, and opened them to the public. The number of participants in our local playing group has increased from four to approximately 40, with the ages of players ranging up to 85. In our community, pickle ball is one of the few, if not only, activities that enables people of all ages to participate together in a cardiovascular sport, while also providing multigenerational socialization that fosters respect for one another. Pickleball courts are a large draw for communities as well. People seek homes and vacation opportunities where courts are available. Berean Park's close proximity to the Lloyd business district is also a plus. Before and after play, participants frequently patronize local stores and restaurants.

Mark Reynolds, reporter, asked where each of the board members stand on the issue of a moratorium on building projects in the town.

Winslow said she is apprehensive about agreeing to a moratorium. She wants to trust the planning board to keep looking into it, and she speaks to Fred Pizzuto, Chairman of the Planning Board, frequently about her concerns with these projects. She certainly does not want to hurt neighbors, or have another situation like what happened on Toc Drive. She wants to know all the facts before making a decision.

- Mazzetti wants to make sure he has all the answers to questions before moving forward with a moratorium. He thinks they should rely on the planning board to come up with a comprehensive plan, but if the plan isn't done quickly enough, and he does not receive something of substance from the building department, then he feels a moratorium may be the only answer, and he will support it.
- Guerriero said he thinks traffic is a major concern and can be a nightmare if a traffic study is not done properly. That short span sees heavy traffic as it is, with the bridge traffic, maybe the county or DOT needs to get involved. Rather than look at one project at a time, all projects should be looked at collectively to better see the entire impact. He would support a moratorium to have a traffic study.
- Supervisor said it's the board's obligation to create a moratorium which has been discussed for the last two years. It only takes a majority to pass a moratorium, and there is more building going on now than there was two years ago. He would not be in favor of a moratorium without a vision moving forward.
- Auchmoody said he believes there is currently a height restriction of 37 <sup>1</sup>/<sub>2</sub>' on the books. We don't do traffic studies, that would be DOT, the county and state. He doesn't think we can pass a moratorium on projects that are already on the books. Winslow said we can.
- Sean Murphy, attorney, said he believes nothing on the books has a vested right., so a moratorium could be passed.
- Auchmoody continued by acknowledging that he must rely on the planning board to make recommendations to the board because he doesn't have the expertise. He doesn't see a moratorium happening, but if the board members convince him it is necessary then he would consider it.
- Mazzetti asked Murphy if a draft for a moratorium can be written if he has board support for a moratorium.
- Murphy replied that the earliest a moratorium could be voted on would be the next meeting, but before it is written it must be decided what exactly the moratorium will be for; either town wide, or a specific area. Also, a public hearing would have to be held.
- Mazzetti said he would want to look at density, height maximum's, setback requirements, buffer zones when a development is infringing on a residential neighborhood, and traffic patterns.
- Murphy stated that some of these issues are already addressed by law and the process that's currently in place. The purpose of a moratorium is to make revisions to the law.
- Mazzetti asked Pizzuto to discuss this with the planning board members to finalize if this is what they want the board to do.
- Pizzuto recommended asking the state and county to do a complete traffic study to see how the traffic flow from these projects around Chapel Hill Road can best be managed. He said they are not looking to stop projects, just slow it down to mitigate the traffic. He's not sure the town can absorb 10% growth in a year or two when it is accustomed to 1% annual growth.
- Sal Cuciti, Planning Board member, indicated that they have been discussing residential density in relation to the Comprehensive Plan. He had suggested a moratorium on larger multi-family, mixed use projects, not 1 or 2 family homes or renovations.
- Rick Bolstad, resident of Macks Lane, said he's in support of a traffic study.
- Joe Kulaga, resident of Macks Lane, wanted to know if the projects can proceed without a traffic studies.
- Supervisor said a traffic study must be completed and submitted to the Planning Board.
- Melanie Bolstad, resident of Macks Lane, said she has been hit twice on Macks Lane because of the way the entrances and exits are situated for Rite Aid and Wingate. Her child was hit head on in that area. She thinks further development in that area is only going to make things worse.
- Murphy said he spoke to NYS Parks counsel who assured him they would not hold the town responsible for any title issues regarding the strip of land located behind the western Walkway welcome center. Parks would also not hold the town responsible for any debris that needed to be removed. They would purchase it as is.

#### Local Law D of the year 2019 Town of Lloyd, County of Ulster

# A local law to override the tax levy limit established in General Municipal

### Law § 3-c

Section 1. Legislative Intent

It is the intent of this local law to override the limit on the amount of real property taxes that maybe levied by the Town of Lloyd pursuant to General Municipal Law § 3-c, and to allow the Town of Lloyd to adopt a budget for the fiscal year 2020 that requires a real property tax levy in excess of the "tax levy limit" as defined by General Municipal Law § 3-c.

Section 2. Authority

This local law is adopted pursuant to subdivision 5 of General Municipal Law § 3c, which expressly authorizes the town board to override the tax levy limit by the adoption of a local law approved by vote of sixty percent (60%) of the town board.

Section 3. Tax Levy Limit Override

The Town Board of the Town of Lloyd, County of Ulster is hereby authorized to adopt a budget for the fiscal year 2020 that requires a real property tax levy in excess of the amount otherwise proscribed in General Municipal Law, §3-c.

Section 4. Severability

If any clause, sentence, paragraph, subdivision, or part of this Local Law or the application thereof to any person, firm or corporation, or circumstance, shall be adjusted by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair, or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this Local Law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

Section 5. Effective date

This local law shall take effect immediately upon filing with the Secretary of State. **Roll call:** Winslow, aye Mazzetti, aye; Guerriero, aye; Hansut, aye; Auchmoody, aye

#### Five ayes carried

D. RESOLUTION made by Auchmoody, seconded by Winslow to create Inflow and Infiltration Reserve to improve the existing Sewer infrastructure (lining the existing sewer mains) which should include but not limited to engineering, bidding, contracting, and the cost of borrowing of funds for this type of improvement. This will be funded by fund balance of \$66,000 (8120.30 budget in 2017 & 2018) and from \$33,000 from line 8120.30 from the 2019 budget and the remaining funds from Mountainside Woods gift of \$12,725.29. Funds will be added as available and budgeted for annually.
