Supervisor said Neil Curri is working on the Climate Smart Community. Dave Barton attended a class that got us 200 points towards the Grant.

Highland Fire District/ Ambulance – Councilmember Fraino

Lighting – Coordinated work efforts with Central Hudson and local developer of Mountainside Woods to get power connect to streetlights on Vista, Emerson and Adams, Work should be completed this week.

Pavilion –Town Highway Department completed installation of the 18 footing piers, the building perimeter drainage pipes and connected to the existing manhole. Requests for estimates were distributed to 4 contractors and posted on the Town website for the concrete slab installation. I am hoping to review bids and vote on the contractor at the November Workshop. The lumber and building materials for the structure should arrive in mid-November.

Ambulance – In order to select a service provider at the November Town Board two bids were received for the 2024 Ambulance service in Lloyd, proposals should be reviewed by board members.

Peter Bellizzi reported this past weekend was the ALS walk and Alzheimer’s walk.

This weekend is Walktoberfest.

The Farmer’s Bridge at 101 New Paltz Road

This is a project they have been working on for some time. They had Peter Meleski, LLC Engineer come out and evaluate every inch. There is more work to be done on it than they anticipated.

They contacted Piasecki Steel Company to get a price on doing the repairs, they are currently working on the Walkway. They came back with a price of \$18,500. Since they are already working in the area and don’t have to remobilize, the price was lower. The supporting rods are wearing away and needed to be replaced. One of the cross bracings is snapped. The Rail Trail spent \$4880 on the inspections; they have another \$15,000 allocated. They are looking at the Recreation funds to fund the rest of it.

Supervisor said they will have to see how much money they have.

Sean Murphy said you will need to get more bids unless it is unsafe.

Bellizzi said it is fenced off because it is considered unsafe. The contractor is available at the beginning of November to do the work in early November.

Zoning Board of Appeals – Councilmember Guerriero

Guerriero reported no new applications this month.

2. OLD BUSINESS

A. Tillson/Toc Update

Curbing is being worked on and should be finished tomorrow. Weather depending, they will start final paving from Linwood to 9W. Once that is done, that area will be completed. This is very helpful for the school buses.

They are pouring the East abutment footings and preparing to pour concrete to set piers and culvert. As of now, we are on target to open December 1st.

NYS DOT requires that 44/55 (Vineyard Ave.) be open one way by November 1st and two way by December 1st.

If they are working, they can shut it down to one lane but they must have flaggers.

B. 69 North Road Remediation has started, Dawes removed the debris from the 29 buckets. The rest will be removed tomorrow. Still waiting on an estimate to remove the vehicle and two boats.

C. Front Foyer

Supervisor said we have three quotes to complete the front foyer. The contractor that did the outside work came back with a price of \$5000.00, Peter Bellizzi \$1850.00, and Gato Construction was \$1707.00.

 Ever since they cut the trees so the plows can get through, the noise that comes off 9W is very loud. The other noise problem comes from the American Legion. She also spoke to the owner of the car wash about the noise it makes and people that play their radios while vacuuming their car.
 Auchmoody said the American Legion is changing what time events can run until. He suggested having the police put the speed trailer up.
 Nutting stated that would come up the hill and try to see how fast they can make the monitor show a faster speed.
 Asked if a sound barrier could be installed to bounce the traffic noise.
 Supervisor stated it is a state road so she would have to ask NYSDOT.
 She asked if they could make the road one way. They have 18 wheelers and buses coming up that road.
 They will talk to the Chief of Police concerning the speeding.
