Town Board Liaisons

Audit – January 1 – June 30, 2022: Councilmembers Auchmoody and Mazzetti July 1 - December 31, 2022: Councilmembers Fraino and Guerriero Beautification – Councilmember Auchmoody

All the brackets for the flags are in. They are going to need assistance to put them up.

Building Department – Supervisor

There have been about 25 inquiries so far for STR applications. That is a pretty good start for the end of the year and going into the new year. The expectation is to get between 40 and 50 inquiries.

ECC (Environmental Conservation Committee) - Councilmember Guerriero

This past Sunday Neil Currie, volunteers and a student from the Highland Middle School Calvin Hayes did clean up on the red and the white bike trails located behind the reservoir.

Calvin Handson has gone from Highland to New Paltz every couple of weeks to do trash pickup to raise money for the National Forest Foundation. He has raised more than \$500 and now has increased his goal to \$1000 for a thousand trees to be planted.

EDC (Economic Development Committee) - Supervisor

Studio 89 is going to start serving Mercurial coffee inside. It was originally on the walkway.

Signs are being replaced between Speedway on 299 and 9W by the police station due to fading and one was broken. The signs were refurbished and will be back up next month.

Highland Fire District/ Ambulance - Councilmember Fraino

Highland Fire Department had 44 alarms with an average response of 11 firefighters per call. Apparatus rolling per call was 2.4 and total number of apparatus responses was 106-man hours for alarms, 232-man hours for meetings, 98 man hours for training and miscellaneous man hours for different activities was 288. All of this totaling 706-man hours for the month of October.

Mobil Life had an increase in calls with a total of 187 calls. No transport calls increased some 38%. 72 of the calls that they responded to they did not transport people. Average response time was eight minutes and twenty-one seconds. There were some questionable calls which included an ALS call that was 23 minutes long.

Highland Central School District - Councilmember Mazzetti

JV and Varsity winter sports that is being held in the gymnasium can now be watched live stream on YouTube. There is a link on the district website. JV and varsity sports start on November 14th and modified sports starts on November 21st. Parent-teacher conference for the elementary school is November 21st from 5-8, the middle school is November 22nd 5-8 and the high school had theirs already at the end of October. John acknowledged that himself and Dave have the pleasure to serve on the board with three veterans: Mike Guerriero, John Fraino and Lenny Auchmoody. On November 10th, Lenny spent time with the fourth graders and John was with the second graders to answered questions regarding Veterans Day. Both John and Lenny said it was a great experience and both the students and teachers were prepared for the day with activities and the kids had plenty of questions. Mr. Plavchak wanted to thank the American Legion for the Veterans Day event last Friday at the memorial. It was well done and well attended.

Highland Landing Park - Councilmember Auchmoody

Working in the inside the building. Many of the fixtures are in. When Anthony has a chance, we will get the fixtures mounted for the bathrooms and finish the plumbing downstairs. The benches are all paid for except for one. The materials for the plaques are mostly in except for two. Lenny will meet with the people handling the installation of the plaques. The docks are out.

The residents that live in Bridgeview seem to be very happy with the new lightning. The remaining four lights will be installed once we have the ok that there is no fiber optic wires or other wires in the area. Once Richie gets the ok the lights will be installed and should only be a one-day job.
