Walk-through was done on 1 Grove Street, the nursing home across the street. The inside of the building has been substantially demolished. Anything that is not structural in

the building such as electrical, plumbing and sprinklers still need to be removed and replaced with new materials.

Dave did Brownfield's webinar two weeks ago that was two hours long. The webinar spoke about grant opportunities. There are two possible Brownfields in Highland.

There is a good amount of STR applications rolling in.

January will be busy. Fire inspections are already being done to expedite the review. There are approximately 25 STR's.

- 1) I reviewed the initial drafts of the four signs which Matt Kierstead created. They look really good.
- 2) Matt has accumulated so much research about the railroads and the rail trail, but only a fraction of this information can be included on the signs. Some of 'unused' research can be used in the publicity for the presentation of the signs; other possibilities to share this knowledge are being explored.

Water & Sewer – Adam Litman

Water Department

1. River water is making up 90% of daily production, the remaining 10% comes from the wells.

2. Production time is still varying between 10 & 11 Hrs. per day.

3. The backwash tank has been cleaned out. Earthcare was onsite for two days and removed approximately seventy thousand gallons of sludge. Pieces of concrete, safety netting and coal was removed from the sump area in the tank. We are now able the process sludge once again.

WHEREAS, ELMS MAIN STREET LLC ("Elms") owns lands adjacent to certain lands of the Town of Lloyd, located in the Town of Lloyd, County of Ulster and State of New York, said lands of Elms being more particularly described in a map entitled "Preliminary Map of Subdivision of Lands of ELMS MAIN STREET, LLC and lot line revision with Lands of The Town of Lloyd said map prepared by Brooks & Brooks Land Surveyors, PC dated March 3rd, 2022 revised May 10th, 2022 and revised May 6th, 2022", and

WHEREAS, a portion of the premises owned by Elms in the vicinity of the Town's planned Lewis C. DiStasi, Jr. Pavilion and the Town feels that it would be in the best interest of the Town to obtain a portion of the premises owned by the Elms as set forth by Parcel A on the above referenced map said parcel containing 0.03 acres to provide an additional buffer for the construction of the Town's planned Lewis C. DiStasi, Jr. Pavilion, and

WHEREAS, a portion of the premises located on the property of the Elms encroach and overhang on to the property of the Town including a wood deck and planters of the existing laundromat structure, located on the property of the Elms, and

WHEREAS, the parties have negotiated an Agreement whereby the Town would transfer certain property from the Town to Elms which parcel is set forth as Parcel B on map number entitled "Preliminary Map of Subdivision of Lands of ELMS MAIN STREET, LLC and lot line revision with Lands of The Town of Lloyd said map prepared by Brooks & Brooks Land Surveyors, PC dated March 3rd, 2022 revised May 10th, 2022 and revised May 6th, 2022" which said transfer would alleviate the overhang and encroachment as set forth above and whereby the Elms would transfer a certain parcel set forth on the above referenced map as Parcel A which said transfer would provide additional land to the Town and create additional buffer space for the construction of the "Lewis C. DiStasi, Jr. Pavilion", and

WHEREAS, the Town is desirous of approving the Agreement as set forth in Exhibit Attached hereto and made apart hereof.

NOW, THEREFORE, IT IS RESOLVED AS FOLLOWS:

1. The agreement attached hereto as Exhibit "A" be and the same hereby is approved by the Town of Lloyd.

2. This Resolution is subject to Permissive Referendum and the Town Clerk shall

publish a notice in the official newspaper of the Town within ten (10) days after adoption of this Resolution containing the information required in Town Law Section 90, which notice shall set forth the date of adoption of the Resolution and contain an abstract of such Resolution concisely stating the purpose and effect thereof and that it was adopted subject to Permissive Referendum.

3. This Resolution is not final and shall not take effect until thirty (30) days after its passage provided no petition is filed with the Town Clerk pursuant to Town Law Section 91 requesting a special election. If an election is so requested the resolution shall not take effect until an affirmative vote is rendered by the voters entitled to vote pursuant to the Town Law.

4. Upon this resolution becoming final and taking effect, the Supervisor is then authorized to sign the Agreement on behalf of the Town and duplicate copies of the Agreement shall be furnished to Elms Hall Corp.

EXCHANGE OF REAL PROPERTY AGREEMENT

This agreement dated the _____day of _____2022, by and between ELMS MAIN STREET LLC ("Elms") a domestic limited liability company having its principal executive office at 7 Broad Street, PO Box 390, Pawling, New York 12564, and

The TOWN OF LLOYD (the "Town"), a New York municipal corporation, having its principal office at 12 Church Street, Highland, NY 12528,

WITNESSETH:

WHEREAS, Elms owns lands adjacent to certain lands of the Town of Lloyd, located in the Town of Lloyd, County of Ulster and State of New York, said lands of Elms being more particularly set forth on a map entitled "Preliminary Map of Subdivision of Lands of ELMS MAIN STREET, LLC and lot line revision with Lands of The Town of Lloyd, said map prepared by Brooks & Brooks Land Surveyors, PC dated March 3rd, 2022 revised May 10th, 2022 and revised May 6th, 2022" a copy of which said map is attached hereto and made apart hereof as Exhibit A, and

WHEREAS, there is a laundromat structure located substantially on the property of Elms, and

WHEREAS, during the course of the preparation of the above-referenced map, it was discovered that part of the overhang and wood deck and planters of the existing laundromat structure which is located substantially on the property of Elms, are located on the property of the Town of Lloyd, and

WHEREAS, the Town feels that it would be in the best interest of the Town to obtain a portion of the premises owned by Elms as set forth as Parcel A on said map, said parcel containing 0.03 acres to provide an additional buffer for the construction of the Town's planned Lewis C. DiStasi, Jr. Pavilion, and

WHEREAS, the Town wishes to transfer a parcel of Land containing 0.03 acres to the Elms which land contains the overhang and wood deck and planters of the existing laundromat structure which are on the property of the Town in exchange for a separate parcel currently owned by the Elms containing 0.03 acres which said parcel is a triangular shaped parcel just northerly and parallel to the pine trees that are the corner of the parking lot where the Town's athletic field is located and in the vicinity of the Town's planned Lewis C. DiStasi, Jr. Pavilion, and

WHEREAS, the parties desire to set forth the terms and conditions of the above referenced transfers.

NOW, THEREFORE, in consideration of the mutual covenants and agreements herein contained, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged by the parties, the parties agree as follows:

1. The ELMS MAIN STREET LLC shall transfer and convey to the Town the property shown as Parcel A on "Preliminary Map of Subdivision of Lands of ELMS MAIN STREET, LLC and lot line revision with Lands of The Town of Lloyd said map prepared by Brooks & Brooks Land Surveyors, PC dated March 3rd, 2022 revised May 10th, 2022 and revised May 6th, 2022" which said map is attached here to and made apart hereof as Exhibit A.

2. The Town of Lloyd shall transfer and convey to ELMS MAIN STREET LLC the property shown as Parcel B on "Preliminary Map of Subdivision of Lands of ELMS MAIN

STREET, LLC and lot line revision with Lands of The Town of Lloyd said map prepared by Brooks & Brooks Land Surveyors, PC dated March 3rd, 2022 revised May 10th, 2022 and revised May 6th, 2022" which parcel is more particularly described in Schedule B attached here to and made apart hereof.

3. There shall be no other consideration in addition to that set forth herein.

4. The Premises are transferred and shall be conveyed subject to zoning and subdivision laws and regulations.

5. The parties acknowledge and represent that each is fully aware of the physical condition of all the properties included in this transfer, based on each party's own inspection and investigation thereof, and that each party is entering into this contract based solely upon such inspection and investigation and not upon any information, data, statements or representations, written or oral, as to the physical condition, use, cost of operation or any other matter related to the Premises included in this transfer, given or made by either party or its representatives, and shall accept the same "as is" in their present condition.

6. The parties shall each accept such title as a New York State licensed title insurance underwriter shall be willing to approve and insure in accordance with its standard form of title policy approved by the New York State Insurance Department, subject only to the matters provided for in this contract. Each party will be responsible for any title searches, reports, or insurance obtained on their behalf.

7. "Closing" means the settlement of the obligations of the parties to each other under this contract, including the mutual transfers of bargain and sale deeds with covenant against grantor's acts of each party to the other.

8. Closing shall take place at the office of Di Stasi, Moriello & Murphy Law PLLC, 400 Upper North Road, Highland, NY 12528 within 10 days after all of the applicable time periods relating to the Town's transfer have expired.

9. Each party shall be obligated to pay all applicable transfer and/or recording taxes or fees payable by reason of the delivery or recording of any documents necessary to effectuate the above referenced transfers.

10. This contract may not be assigned by either party without the prior written consent of the other party in each instance and any purported assignment(s) made without such consent shall be void.

11. (a) All prior understandings, agreements, representations and warranties, oral or written, between the parties are merged in this contract; it completely expresses their full agreement and has been entered into after full investigation, neither party relying upon any statement made by anyone else that is not set forth in this contract.

(b) Neither this contract nor any provision thereof may be waived, changed or canceled except in writing. This contract shall also apply to and bind the heirs, distributees, legal representatives, successors and permitted assigns of the respective parties. The parties hereby authorize their respective attorneys to agree in writing to any changes in dates and time periods provided for in this contract.

(c) Any singular word or term herein shall also be read as in the plural and the neuter shall include the masculine and feminine gender, whenever the sense of this contract may require it.

(d) The captions in this contract are for convenience of reference only and in no way define, limit or describe the scope of this contract and shall not be considered in the interpretation of this contract or any provision hereof.

(e) This contract shall not be binding or effective until duly executed and delivered by the parties.

(f) The parties shall comply with IRC reporting requirements, if applicable. This subparagraph shall survive Closing.

(g) Each party shall, at any time and from time to time, execute, acknowledge where appropriate and deliver such further instruments and documents and take such other action as may be reasonably requested by the other in order to carry out the intent and purpose of this contract. This subparagraph shall survive Closing.

(h) This contract is intended for the exclusive benefit of the parties hereto and, except as otherwise expressly provided herein, shall not be for the benefit of, and shall not create any rights in, or be enforceable by, any other person or entity.
