SETTING A PUBLIC HEARING AND MAKING A REFERRAL TO THE ULSTER COUNTY PLANNING BOARD

THE FOLLOWING Resolution was moved by Auchmoody and seconded by Fraino as follows:

WHEREAS, pursuant to Town of Zoning Code ("Zoning Code") § 100-23.2(B)(3), in June 2022 the Town of Lloyd Town Board (the "Town Board") received an application from The Villages in the Hudson Valley, LLC for a proposed Planned Residential Retirement District ("PRRD") to be constructed on a portion of 57.07± acres located on NYS Route 9W and Mayer Drive in the Town of Lloyd, Ulster County, New York shown as Lot Nos. 1 and 2 on Filed Subdivision Map 2022-117 and a portion of the following neighboring tax parcels (SBL## 95-12-1-1 and 95.2-2-34.110) (the "Application"); and

WHEREAS, pursuant to Zoning Code § 100-23.2(B)(5), on July 20, 2022 the Town Board referred the Application to the Town of Lloyd Planning Board (the "Planning Board") for recommendations and also to serve as SEQRA lead agency for the environmental review of the PRRD since the Planning Board will be responsible for site plan review of any PRRD adopted by the Town Board; and

WHEREAS, the Planning Board, after a thorough review of the Application as supplemented during the Planning Board's review, adopted a SEQRA Negative Declaration for the proposed PRRD at its regular meeting on December 1, 2022, concluding that the PRRD would not have any significant adverse environmental impacts; and

WHEREAS, pursuant to Zoning Code § 100-23.2(B)(6), on December 1, 2022 the Planning Board adopted findings with respect to the factors set forth in Zoning Code § 100-23.2(A)(6) and recommended approval of the proposed PRRD based on its review of the supplemented Application and its SEQRA determination; and December 21, 2022

WHEREAS, pursuant to Zoning Code § 100-23.2(B)(6), the Town Board is required to hold a public hearing on the proposed PRRD; and

WHEREAS, pursuant to General Municipal Law § 239-m, referral of the proposed PRRD to the Ulster County Planning Board is required prior to any Town Board decision on the Application, as supplemented, because the proposed PRRD would be within 500' of NYS Route 9W.

NOW, THEREFORE, BE IT RESOLVED: that a public hearing will be held by the Town Board with respect to the adoption of the proposed PRRD at the Town Hall on the 18th day of January, 2023, at 7:00 P.M.; and

BE IT FURTHER RESOLVED, that the Town Clerk is directed to forward the Application, as supplemented, and the Planning Board's SEQRA Negative Declaration and Recommendations to the Ulster County Planning Board for review pursuant to GML § 239-m; and

BE IT FURTHER RESOLVED, that the Town Clerk is directed to publish and post notice of said public hearing as required by law.

"WHEREAS, on December 1, 2022, representatives of the Town and the CSEA, Local 1000 AFSCME, AFL-CIO, Town of Lloyd Unit 8964, Ulster County Local 856 (hereinafter referred to as the "CSEA") on behalf of the members of the bargaining unit agreed in principle to a Memorandum of Agreement to create a three-year successor Collectively Negotiated Agreement effective January 1, 2023 and terminating on December 31, 2025, to the one which expired on December 31, 2022; and

Local Law I-2022, a local law to amend the Code of the Town of Lloyd, Chapter 98 "Water", Article IV "Rates", Sections 98-13, 98-15, 98-18, 98-19, and 98-20.1 to provide that the rates charged pursuant thereto may be set by resolution of the Town Board. (copy of Local Law attached)

WHEREAS, this Board desires to hold a Public Hearing with respect to the adoption of the said local law;

NOW, THEREFORE, BE IT RESOLVED that a Public Hearing will be held by the Town Board with respect to the adoption of the aforesaid local law at the Town Hall on the 18th day of January, 2023 at 7:00 p.m.; and it is further

RESOLVED, that the within local law is a Type II action pursuant to the State Environmental Quality Review Act (SEQRA) and is exempt from further proceedings under such act; and it is further

RESOLVED, that the Town Clerk is hereby directed and authorized to cause public notice of said hearing to be given as provided by law.

LOCAL LAW 10 – 2022

A LOCAL LAW TO AMEND THE CODE OF THE TOWN OF LLOYD CHAPTER 98 "WATER", ARTICLE IV "RATES", SECTIONS 98-13, 98-15, 98-18, 98-19, and 98-20.1 TO PROVIDE THAT THE RATES CHARGED PURSUANT THERETO MAY BE SET BY RESOLUTION OF THE TOWN BOARD.

Section 1

The Code of the Town of Lloyd, Chapter 98, entitled "Water", Article IV, entitled "Rates", be and the same is hereby amended by deleting existing Sections 98-13, 98-15, 98-18, 98-19, and Section 98-20.1, and enacting new sections as follows:

"Section 98-13. Rates established.

The rates for service and water supply to any customer of the Highland

Water District shall be levied on the basis of the amount of water from the Highland Water District used by each water using at such per gallon, or fraction thereof, rates as the Town Board may from time to time establish by resolution and amended from time to time."

"Section 98-15. Rate of water supply to non-metered users.

The rate for water supplied to non-metered users shall be levied on the basis of the amount of water from the Highland Water District used by a non-metered user at such per gallon of water, or a fraction thereof, rate as the Town Board may from time to time establish by resolution and amended from time to time."

"Section 98-18. Restoration charges.

In any case, where service has been discontinued or terminated, a restoration fee shall be paid before water service and water is supplied. Such restoration fee shall be set as the Town Board may establish from time to time by resolution, and amended from time to time."

"Section 98-19. Charges for fire hydrants and sprinkler systems.

A. There shall be an annual charge per hydrant made to the Highland Fire District for the furnishing of water service and water. Such charge shall be set by the Town Board by resolution, and amended from time to time.

B. There shall be a quarterly charge for any sprinkler or other fire-protection system connected to district water services that is nonmetered, which charge shall be set by the Town Board by resolution and amended from time to time."

"Section 98-20.1. Fees for meter readings.

Consumers requesting a reading of their water meters other than the customary quarterly meter readings shall be charged a fee, which fee shall be set by the Town Board by resolution and amended from time to time."

Section 2

This local law will take effect when filed with the Secretary of State in accordance with the Municipal Home Rule Law.

WHEREAS, Mobile Life Support Services, Inc. (MLSS) presently provides Ambulance Service to the Town of Lloyd pursuant to an Agreement dated the 10th day of March 2022, which said Agreement expires December 31, 2022; and

WHEREAS, the parties wish to replace said Agreement with an Agreement to be effective on January 1, 2023 and expire on December 31, 2023, with two one-year option periods, which the Town may exercise for the periods of January 1, 2024 to December 31, 2024, and January 1, 2025 to December 31, 2025, pursuant to the terms of the "Ambulance Service Agreement" attached hereto and made a part hereof.

NOW, THEREFORE, IT IS RESOLVED AS FOLLOWS:

- 1. The Agreement attached hereto as Exhibit A be, and the same hereby is, approved and the Town Board hereby enters into said Ambulance Service Agreement commencing on January 1, 2023 and expiring on December 31, 2023 with two one-year option periods, which the Town may exercise for the periods of January 1, 2024 to December 31, 2024, and January 1, 2025 to December 31, 2025, for the consideration set forth in the Agreement.
 - 2. The Supervisor is authorized to sign the Agreement on behalf of the Town.
