### 1. REPORTS – Town Board Liaisons

Audit –January 1 to June 30, 2019: Councilmembers Auchmoody and Mazzetti July 1 to December 31, 2019: Councilmembers Winslow and Guerriero ECC /Zoning Board – Councilmember Guerriero No Report

Highland Central School District - Councilmember Mazzetti

Mazzetti reported that school is out, all the graduations went well, in spite of the storm during the High School Graduation. Summer enrichment programs have started.

#### **Planning Board** – Councilmember Winslow

- The Views, corner of Chapel Hill Road and Rt. 9 W, have submitted a new traffic study with some proposed mitigation that would change the slip lane behind Sunoco (one proposal would have north and south lanes behind Sunoco, one proposal would have two south bound lanes-a right and a left onto Chapel Hill). The Board has not seen those new proposals yet, they will be on the agenda for tomorrow night at the workshop.
- The Villages has officially submitted. That is the senior development across from Hannaford. The official review begins tomorrow. The Planning Board will be holding an informational meeting about the project for the residents of Hudson Hills soon, very likely next month.
- Glidepath, an energy company, has met with Dave Barton concerning a proposal for a grid tied battery peak plant. It is proposed to be a one-story warehouse located to the east of the DOT property behind the 299/9W parking area. It doesn't appear to be proposed to be visible from the highway at all. That review also starts tomorrow.
- Stewarts is meeting with Dave this week for the first preliminary sit down. There is no projected submission date yet, but Dave thinks it will be very soon, perhaps August.
- AutoZone has also been in contact, with some preliminary and conceptual designs submitted. They are working on engineering now, and will submit soon.
- One light industrial warehouse is also being submitted for August, on Upper North Road in the LI zone. Very light intensity, mostly storage for a design firm.

### JULY 17, 2019

June 12<sup>th</sup> - Lt. Janso, Sgt. Roloson & Officer Burns brought the Highland High School Flex Class cupcakes and cookies during their lunch break to celebrate the end of another great school year.

June 18<sup>th</sup>- Town of Lloyd Police is investigating a two-car fatal motor vehicle accident that occurred at approximately 8:00am on Rt. 9W near the intersection of Argent Drive in Highland. A 1995 Saturn driven by a 57-year-old Dutchess County man was traveling south on Rt. 9w when he crossed over into the northbound lane of Rt. 9w and was struck by a 2016 Ford transit cargo van that was traveling north on Rt. 9w. The Dutchess county man was transported to Mid-Hudson Regional Hospital by Mobile Life Support Services where he was pronounced deceased. The driver of the cargo van, a 29-year-old Dutchess County man and 5 passengers in the van were transported to Vassar Hospital by Mobile Life Support Services with minor injuries, one passenger, and a 69-year-old Ulster County man died several days later at the hospital from his injuries. Rt. 9W was shut down for approximately three hours while police investigated the accident. Lloyd Police were assisted by New York State Police, New York State Police Crash Reconstruction Unit, Highland Fire Department and Mobile Life Services.

June 25<sup>th</sup> -Chief Waage stopped by the Highland High School to see the Flex Class on their last day of school prior to summer break.

**June 30**<sup>th</sup>- Lloyd Police provided traffic for the Bike NY event they crossed the Walkway Over the Hudson Bridge is traveling through the Town of Lloyd this morning. Several roadways within the Town of Lloyd will be shared with cyclists and we ask that you please use caution when traveling this morning. ### 4. PRIVILEGE OF THE FLOOR

Dave Plavchak said he felt the Comprehensive Plan Review Committee is dominated by Planning Board members and he would think you would want a variety of members representing the business community, finance, etc.

- Mazzetti said they have experts on the Planning and Zoning Board and if you look at their expertise, they are very diverse. Once the committee looks at the plan if they decide they need to expand the committee they can look to the community, but they are all community members.
- Plavchak reiterated that he doesn't think it is right to have one board dominate the committee.
- Winslow said she thinks that Jeff Palladino feels the same way.

Jeff Palladino asked, given the traffic concerns with the Villages project, if traffic mitigation has been discussed. Have traffic calming ideas been discussed.

Winslow said they have been discussed and representatives are here from Hudson Hills.

Lindsay Decker, Highland Hills Development on Salk Drive.

I, as well as other residents have a concern that with the potential of two new projects starting on either side of our development that the traffic flow will enter Highland Hills. Since our development does not have sidewalks to keep our families safe we are asking that you please consider these suggestions.

The speed limit in our residential neighborhood is at 30 miles per hour. We have a sign at the beginning of Mayer that is covered by a tree, two signs on Roy and one on Hudson.

Although this speed limit is too high, we ask that you would place additional speed limit signs, along with children at play signs on every road.

After speaking with the building department director, highway superintendent and the chief of police we also ask that you please consider a traffic study to lower the speed limit to 15 miles per hour. A copy of a petition was sent to the board's attention with the 169 residents who were in favor of a speed limit reduction to ensure the safety of our families.

Some additional items discussed were the possibility of speed bumps being installed to slow drivers down. This was also agreed upon with the 169 residents who signed the petition.

Finally, at minimum we are asking for a 3 way stop at every intersection in Highland Hills. It is a necessity. Children ride bikes in the neighborhood and need to cross roads where cars may not be able to see due to limited view because of the hills. Making these cars, stop with these signs will be helpful to the children in our development. We are asking for a 3 way stop at all 8 intersections in the development.

I called the Highland School District transportation department to find out how many buses are needed for the 5 roads in our development. There are 4 needed, two for the elementary school and two for the middle/high school routes. This is not including the younger children who are not school age yet. Something needs to be done for the safety of these children.

Some residents have met with Dave Barton, Building Department Director and Rich Klotz, Highway Superintendent and discussed more stops signs, children at the play signs and perhaps reduction in speed limit.

We, the undersigned residents of the Town of Lloyd, Highland Hills Community, dispute the approval of the building permits for the "The Views" development at the current proposed location 3715-3725 Route 9W, Highland. We feel this will impact our quality of life due to:

- Increase of traffic on Mayer as well as the rest of the neighborhood due to possibility of commercial vehicles entering and exiting.
- Flow of traffic that could move through the development endangering children playing.
- Impact of increased demand on water and sewer system.
- Overpopulation of schools due to increased residential space.
- Noise pollution in a quiet residential development.

Overall, we feel the development of "The Views" would negatively impact the safety of our neighborhood and directly affect our children and families who reside in the Highland Hills development in the Town of Lloyd. The residents would also like to be notified of the Department of Transportation, Water and Sewer and other relevant studies of "The Views" project.

Richard Michaels, 19 Roy Lane said he agrees with stop signs but reducing the speed limit to 15 MPH is much to slow.

Dave Barton said he has driven the area several times and agrees that it needs more stops signs. He and Rich Klotz have discussed the issues and the additional signs are not an issue but to change the speed limit it would need to go through NYSDOT.
