# TOWN OF LLOYD TOWN BOARD REGULAR MEETING May 16, 2018

**7:00 PM** – Supervisor opened the meeting with the Pledge of Allegiance Supervisor asked the Boy Scouts to lead the Pledge of Allegiance

1. **REPORTS** – Town Board Liaisons

Audit –January 1 to June 30, 2017: Councilmembers Auchmoody and Mazzetti July 1 to December 31, 2017: Councilmember Winslow and Guerriero ECC /Zoning Board – Councilmember Guerriero

- Councilmember Guerriero reported that June 30<sup>th</sup> will be the Kayak and Canoe Tour on the Black Creek. Canoes and Kayaks will be available for rent for \$10.00. The rental must be reserved by contacting Neil Curri, ECC, Chairperson.
- The Lloyd Leaf, newsletter of the ECC, is published and has great articles about the crude oil on the Hudson River and how to deal with a Bear.
- The Zoning Board of Appeals had a public hearing and granted an area variance for a porch. There is another area variance request for a deck and the public hearing is in June. There is an application for a Use Variance for a house that at one time was used commercially and they want to again use it commercially.
- He and Rich Klotz, Highway Superintendent met with Tim Rhodes and Charlie Whitaker representatives of Ulster County Resource Recovery Agency at the present transfer station and former landfill on Lily Lake Road. All the water seeps down from the top of the landfill. There is a liner at the bottom and the water builds up along the bottom of the landfill and needs to be removed. There is a road in the back of the landfill that needs to be developed so the trucks more easily access the leachate.
- Richard Klotz said that they discussed emptying the leachate collection that was at the Transfer Station in the meeting with the Beacon Treatment Plant. The records from Ulster County Resource Recovery Agency indicate that an average of 35,000 gallons were pumped out annually. This has not been done since 2014 at the Town of Lloyd Transfer Station. The cost of 16 cents per gallon includes trucking and disposal of the leachate and close to 45,000 gallons could need to be pumped. The estimated cost is \$7,200 which comes from the General Fund. NYS DEC requires this and it must be performed. The unexpended capital improvement monies in budget line 8260.50 totaled \$25,504.20 at the end of 2017. This should cover the cost of the required Transfer Station upgrades. They discussed that a roadway should be installed for access to the well head. A roller would be rented and labor would be an additional cost. The estimated cost is \$2500 plus labor and should be done as soon as weather permits. He will start paving the town roads again in early July.

### Highland Central School District - Councilmember Mazzetti

Mazzetti reported that the end of the school year is approaching and the students are preparing to take their Regents Exams. The school budget vote was Tuesday and the budget passed as well as the propositions for new buses and for construction and new security systems.

Supervisor commented that 800 people voted out of 8000 registered to vote.

#### Planning Board – Councilmember Winslow

Winslow said the Planning Board meeting begins at 5:30pm tomorrow. Under new business. On the agenda is Altamont Farm which is now ADC Ulster, LLC-Falcon Ridge Subdivision, 301 Upper North Rd., SBL# 80.3-1-18.110 & 80.3-1-31, in R1 and LI Zone. The applicant proposes to develop a 240-Lot Residential Conservation Subdivision of existing tax lots SBL's 80.3-1-18.11 and 80.3-1-31 with frontage along Upper North Road and North Chodikee Lake Road. The site is within the Town's water

district and is proposed to be served with municipal water. The site is not within the existing Town sewer district and applicant proposes to extend sewer service to the project site.

- Under new business is also the property near her property on North Road, Front Street Owners / 7 Lot Subdivision, 96 North Road, SBL# 88.1-4-8.220 in GB Zone and R ½ Zone. The applicant is proposing to subdivide the existing one-acre lot into two 1/2 acre lots and create two additional residential lots of 1.8 acres each. The residential lots will have access directly onto North Road with water and sewer availability. Applicant is also proposing to create three larger lots for sale: Lot 5 - 9.08 acres in R 1/2 zone with frontage on north Road, Lot 6 - 8.12 acres in GB zone with frontage on Rt 9W and Lot 7 - 15.22 in GB and R 1/2 zone with frontage on north Road and Rt 9W. On the agenda under old business is the Public Hearing on Dollar General Store which will be in June. That project includes 72 housing units. There is an application for a 4-bay service facility for foreign automobiles On Rt. 299 which will likely get approved this month.
- Supervisor asked Winslow if this was a Planning Board review. It would not come in front of the Town Board since there is no rezoning.

Winslow confirmed.

Supervisor reminded everyone to attend or watch the Planning Board meetings on

television if they want to be informed or have any questions or concerns. There will be no action in the Town Board other than the sewer line. They are going to start up the Tri-Board meetings again to discuss projects like Falcon Ridge, the adaptive re-use law and the Comprehensive Plan. This will assure that all the boards are on the same page when questions or comments arise. The first Tri-Board meeting will be on June 6<sup>th</sup> at 7:00 PM. They will develop an agenda and decide how they are going to move forward. The public is welcome and there will be time for public comment.

Guerriero commented that ECC would like to participate in the Tri-Board Meetings.

#### **REPORT** – Peter Bellizzi, President, Hudson Valley Rail Trail

Peter Bellizzi reported that the HV Rail Trail at 75 Havilland Road to the Walkway Over the Hudson has been paved and re-opened. The detour has been removed. The contractor is working on the NYS Parks parking lot. He hopes to be able to put the gateway sign up in June. The High Bridge apartment project off Linwood Ave. is moving along. He is waiting for Mountain Side Woods to bring the sewer line down along the Rail Trail.

Phase III and IV of the Rail Trail are progressing. They are preparing to pour the foundation for the new tunnel under South Riverside Road. They will do the south side first, move the fiber optics, put in storm drains and then move to the north side. Phase IV should be completed in October.

He attended the NYSDOT meeting on Phase V of the Rail Trail which goes along Route 299 from South St. across the NYS Thruway (I87) overpass. They plan to start in August and be at substantial completion by the time the Hudson Valley Rail Trail is complete. The bridge over the thruway will have a 10-foot-wide trail and be protected by a concrete barrier.

The Hudson Valley Rail Trail Annual Meeting Breakfast is on June 2<sup>nd</sup> at 9:00AM and all are invited.

- Supervisor said that Ray Jurkowski, Engineer from Morris Associates, met with Bellizzi on the Eagle Scout project the "Little Italy Bridge". Jurkowski made some minor changes and the Town Board will approve the project in Resolution P.
  - The Town has received a \$196,000.00 NYS grant to repave Phase 1 of the Hudson Valley Rail Trail. It could take a couple of years before NYS disburses the money so they discussed the Town paying for the paving and then getting reimbursed. Part of the grant is federal funds; they are working on getting federal approval before they can move forward.
- Bellizzi said Colarusso Contractors are paving Phase III and IV of the Rail Trail and they wanted to have them do the repaving of phase I. The town would get a better price while the equipment is already on site.
- Casey Rosen, Boy Scout, thanked the Town for their support of his Eagle project.

**REPORT** – Leonard Auchmoody, Manager, Bob Shepard Highland Landing Park

Auchmoody reported that the gutters have been installed on the outdoor classroom or pavilion and the concrete Riverwalk is complete to the south end of the property. They have seeded and mulched but after the hard rain he is not sure what is left. The north dock at the boat ramp has been put in the water. He is working on getting electric from the building to the outdoor classroom. The steel structure that is going between the two poles at the entrance to the main dock is almost complete. The plaque for Assemblyman Skartados has been ordered. It will be placed on the roadside of the Education Center between the two windows with a down light shining on it. The plan is to dedicate the building and unveil the plaque in August at the Highland Landing Park Association Annual Meeting at the Park.

## 4. PRIVILEGE OF THE FLOOR

- Mark Reynolds, reporter asked if the Falcon Ridge project does not need a zoning change.
- Supervisor responded that it is currently R <sup>1</sup>/<sub>4</sub>. They are single family homes on 240+ lots and he understands they do not need a zoning change,
- Fred Pizzuto, Planning Board member, said there is a conservation exemption and <sup>1</sup>/<sub>4</sub> acre lots.
- Mazzetti asked Pizzuto to be aware because Dave Barton, Building Department Director mentioned that they may ask for more density in exchange for running the sewer line.

Winslow added that this is a big project that will be under review for a long time.

- Reynolds asked in reference to resolution H referring to the Tax Certiorari, what the assessment was before, what it is now and how much do they pay in taxes.
- Winslow said the assessment was \$683,900.00 and is now \$583,900.00 which is a \$100,000.00 less. There will not be a refund.
- Sean Murphy, Attorney, said they challenged the assessment for 2017 so the settlement was for 2017 and they agreed not to take a refund. The assessment of \$583,000.00 will stay in effect for three years, 2018, 2019 and 2020. they will pay taxes based on that assessment.
- Charles Meuser, resident, said the people who were opposed to the Altamont Farms Race Track should take a ride to Sullivan County where that company built the track. They spent over \$100 million dollars; it is beautiful and you can't hear it. He felt it was a shame that we did not allow that to happen in Town of Lloyd.
- Wesley Salis, Ose Road, asked when the Town of Lloyd became responsible for the post closure maintenance of the landfill.

Supervisor responded that the contract with UCRRA expired February 3, 2018.

Salis asked where the Rail Trail will cross Rt. 299 before going over the Thruway.

Murphy responded that it will cross at the College Diner.
