Winslow requested that a resolution be added to purchase a 2019 Chevy Tahoe or equivalent for the Building Department not to exceed \$40,000.00 using the New York State bid process and that the Ford Explorer will be auctioned to offset the cost.

Mazzetti asked what they are doing with the Equinox.

Supervisor said they are preparing a list of vehicles to be auctioned in February. He asked Winslow where the money was coming from for the Tahoe. The last discussion was for a \$23,000.00 vehicle and the resolution was tabled as the "process" was not followed. Now you want to follow the bid process to purchase a \$40,000.00 vehicle that is not in the budget.

Winslow said she understood that there is \$27,000.00 set aside. The balance will be paid by loan payments.

Mazzetti said the loan payment is the same amount as the current vehicle loan payment which is in the budget and will be paid off this year so there will be is no additional cost.

Winslow added that it would be put in the 2020 budget.

Supervisor said the Building Department has approximately \$12,000 in the equipment line. The Ford Escape for \$23,000.00 was coming from the 2018 unexpended.

Mazzetti said that Barton and Karen McPeck, Bookkeeper, can figure out how to pay for it.

Kate Jonietz, Secretary to the Supervisor, said that the last loan payments for the Explorer will come from the \$12,000 in the 2019 equipment line and the balance won't be enough to make the new loan payments.

Winslow said Barton has figured out how he is going to pay for it.

Mazzetti said he could use the \$23,000.00 that was set aside to offset the loan payments.

Supervisor said there isn't \$23,000.00 set aside. That amount was coming from the 2018 unexpended funds and the 2018 budget is closed.

Appointments made by the Supervisor:

Supervisor said he did not have anyone assigned as liaisons because he did not have a chance to discuss

with each board member what they wanted.

Winslow said she wanted to remain as liaison to the Planning Board.

Mazzetti said he wanted to remain as liaison to the school district.

Supervisor said he would like would like to eliminate the school liaison and put together a finance committee to prepare a five-year financial plan.

Mazzetti said he would consider it.

Mazzetti said he received an email from the Association of Towns with their opinion on Affordable Housing. Association of Towns said the Town could look at past developments that did not follow the Affordable Housing Law. He is uncomfortable with having a Town law with waivers. He feels the Town laws are too loose.

Guerriero said he spoke with Guy Kemp from RUPCO who will come to a Town Board meeting to discuss Affordable Housing.

Mark Reynolds asked if the Town is going to appoint an officer to oversee the Affordable Housing Act. Winslow said they may not need to if RUPCO would oversee it.

Reynolds asked if the Tremont Hall (High Bridge project) has done anything about the bridge over the Twaafskill Creek to Vineyard Avenue and about a trail from the Rail Trail to Vineyard Ave.

Supervisor said they are going to build a sidewalk down the Commercial Ave. Ext to Commercial Ave. Winslow added that the developer of High Bridge is going to bond the bridge and begin work in the Spring.

Mazzetti said the Building Department has a letter that certifies that the bridge is safe for Firetrucks. They just need to shore it up.

Reynold asked if they were going to hold back the Certificate of Occupancy for High Bridge until they find out about the Affordable Housing requirements.

Supervisor said the CO is issued by the Building Department. He said it is the "opinion" of the Association of Towns that you could go back and require low income units in developments. He felt it would be difficult for the Town to go back to developments that have rented units and enforce that law.

Mazzetti requested executive session to discuss RFP for a Labor Attorney. He said he sent out information about a law firm and would like to send out RFP's so they can interview law firms.

Supervisor said they do not do RFP's for Attorneys, they are considered Professional Services. They can discuss law firms at the regular meeting.
